## Allen Elementary Advisory Council

Meeting Date: 03-04-2020

Present: Kay Rodebaugh, Vicki Pack, Jessica Hall, Natalie Hayden, Jacob Roberts, Tina Williams, Lisa Branham, Tim Combs, Sarah Roberts and Bonnie Hackworth

Welcome introduction was given by Kay Rodebaugh, then introductions from the council members.

Budget Report was stated that the startup budget was \$571.23 and awaiting the contingency from finance. Will be adjusted and reviewed when new budget is provided. The council discussed lack of school programs due to limited FRYSC funding. Jessica Hall suggested applying for mini grants with ASAP. Motion to approve and accept by Jessica Hall. It was seconded by Bonnie Hackworth and Sarah Roberts.

The council then reviewed coordinating events and services from August 2019 through February 2020. Kay Rodebaugh discussed upcoming events such as Parent Café and Tiny Eagles Academy. Kay Rodebaugh discussed how FRYSC has partnered with Gear-Up, ARH, Save the Children, and other sponsors. Tina Williams mentioned Reality Store that is coming up March 20 that FRSYC is also partnering with. Jessica Hall made a motion to accept the report. It was seconded by Sarah Roberts.

The council tabled reviewing FRSYC By-Laws till they are reviewed by Theresa Combs.

The council discussed staff of the FRYSC. Due to limited budgeting it was discussed and suggested that the Project Clerk be eliminated for 2020-2021 school year. Other district coordinators have eliminated and operated without a Project Clerk, thus providing more funding for the FRYSC. Reviewed all duties that Kay Rodebaugh would have to take care of the following school year. Tina Williams mentioned that FRSYC could partner up with Gear-Up to assist with programs, if the position is eliminated. Jessica Hall made the motion to approve to terminate position, Sarah Roberts and Tina Williams seconded the motion.

Sarah Roberts made motion to adjourn meeting, Tim Combs seconded the motion.
