

BACKGROUND INFORMATION:
The Preschool Extended Program (PEP) was created approximately 15 years ago to increase enrollment in preschool programs at the old preschool center (currently home to Safe Harbor). It is a state licensed daycare serving approximately 15 students per day. Students attend preschool in the mornings and daycare rest of the week. It is not required by regulation. The program had to move from Preschool Center to Southside to Simmons due to space needs at those locations.  SUMMARY OF MAJOR ELEMENTS:
The enrollment of eligible preschool students has increased steadily, substantially during the last year and this year(chart attached). For the last two years we have used almost every slot available and had to add a new classroom in March 2019. We need to make room for projected increases next year and propose to eliminate the daycare program and use the room at Simmons in the afternoon to be able to add another classroom when needed.
IMPACT ON RESOURCES: negligible. Program paid for itself with little carry forward
