PRESENTATIONS: SMOKE FREE CAMPUS PRESENTATION

Ben Chandler, President and CEO of Foundation for a Health Kentucky was present to give the Board an over view of the Smoke Free Campus initiative that was implemented in Christian County Public Schools in 2019.

MILITARY CONNECTED STUDENTS

Susie Hartline, Director of Strategic Planning/Federal Programs/Grant Development; Tracey Leath, Interim Director of Strategic Planning/Federal Programs/Grant Development; Melissa Silva and Tayranette Johnson-Williams, Fort Campbell School Liaison Officers presented a PowerPoint presentation to update the Board on Military Connected Students (a copy of which is attached to the board minutes.)

Nine percent (745 students) of Christian County Public Schools is made up of military connected students. The group discussed strengths and challenges for those students. They also made the board aware of how important the impact aid survey is and the challenges to collecting the impact aid data. They are currently brainstorming options for collection of the important data.

STUDER PARENT AND STUDENT SURVEY RESULTS

Mary Ann Gemmill, Superintendent, began the presentation by stating that the District has updated their Scorecard based on the most recent parent survey results and each person would like to give their Scorecard update in their respective departments (a copy of the PowerPoint is attached to the minutes). She also stated the leadership teams maintain a focus on data to identify gaps, take actions and follow through to ensure continuous improvement. Christian County is recognized as a regional leader of continuous improvement and on February 12th, the Studer Education Group invited our team to be guest presenters at the Kentucky Showcase.

Jessica Addison, Interim Chief Instructional Officer, discussed her Scorecard updates in the Student Learning area.

Laura Morris, Chief Administrative Officer, discussed her Scorecard updates in the Staff and Student Support Services area.

Brad Hawkins, Chief Operations Officer, discussed his scorecard updates in the Operations Services area.

Tracey Leath, Interim Director of Strategic Planning, Federal Programs, and Grant Development, stated they are currently awaiting the results of the Student Survey and they will update the board when that information is available.
