- 16 (2) "Average years of experience" means the average number of years of professional experience
- of classroom teachers excluding certified staff such as administrators, guidance counselors, or
- 18 media specialists.
- 19 (3) "Base year" means the academic year immediately preceding the publication of the school
- 20 report card components.

- 1 [(4) "Core academic subject" means English, reading or language arts, mathematics, science,
- 2 foreign language, civics and government, economics, arts, history, or geography.]
- 3 (4) [(5)] "District report card" means the summary of district and school information that shall
- 4 [may] be published [in the newspaper with the largest paid circulation in the county in which the

- (a) What this administrative regulation does: This administrative regulation establishes the standards for a school and district report card.
- (b) The necessity of this administrative regulation: : KRS 158.6453 (17) requires the Kentucky Board of Education to promulgate an administrative regulation to define the implementation and the components of a school and district report card that clearly communicates with parents and the public about school and district performance.
- (c) How this administrative regulation conforms to the content of the authorizing statute: This administrative regulation provides information necessary for the state report card program The regulation relates to the reporting requirements of KRS 158.6453, KRS 158.6455 and the requirements of 20 U.S.C. 6311(h).
- (d) How this administrative regulation currently assists or will assist in the effective administration of the statutes: This administrative regulation provides requirements for school and district report cards.
- (2) If this is an amendment to an existing administrative regulation, provide a brief summary of:
- (a) How the amendment will change this existing administrative regulation: The amendments align the school and district report cards to the new federal and state requirements. It also adds a new section on communication around federal and state school accountability classifications.
- (b) The necessity of the amendment to this administrative regulation: The amendment aligns the school and district report card program to federal and state guidelines.
- (c) How the amendment conforms to the content of the authorizing statute: The amendment provides information necessary for the report card program. The amendment relates to reporting data from requirements of KRS 158.6453, KRS 158.6455 and the Every Student Succeeds Act of 2015.
- (d) How the amendment will assist in the effective administration of the statutes: The amendment will provide definitions and components required in the school and district report card.
- (3) List the type and number of individuals, businesses, organizations, or state and local governments affected by this administrative regulation: All public school districts in Kentucky and supporting staff at the Kentucky Department of Education.

- (4) Provide an analysis of how the entities identified in question (3) will be impacted by either the implementation of this administrative regulation, if new, or by the change, if it is an amendment, including: The regulation will impact schools and districts by providing school and district report card requirements.
- (a) List the actions that each of the regulated entities identified in question (3) will have to take to comply with this administrative regulation or amendment: Schools and school districts will have to verify information and data in the report cards for accuracy. In addition, schools will have to place the accountability ratings in a prominent location in the school building, or hold an advertised public meeting to discuss the school's accountability rating, plan for sustainability or improvement. In addition, each school shall provide a written or electronic form of communication that states the accountability rating, which includes star ratings, program offered, and a link to the school report card.
- (b) In complying with this administrative regulation or amendment, how much will it cost each of the entities identified in question (3): Amendments to the regulation may impact school budgets. Schools may be responsible for printing and mailing costs associated with written notifications to parents and guardians, along with minimal costs associated with displaying accountability classifications in a prominent location. The Kentucky Department of Education will provide templates to districts as guidance for the letters and displays.
- (c) As a result of compliance, what benefits will accrue to the entities identified in question (3): Kentucky schools and districts will have a clear communication tool on academic performance, educational opportunities, transition readiness, school accountability, school safety and financial transparency.

- IV. Summary of Comments and Responses
- (1) Subject Matter: Communication on federal and state school accountability classifications.
- (a) Comments: A commenter believes that the new section added on communication on federal and state school accountability classification is unnecessary and further micromanages school districts. The commenter states that school ratings and report cards are published in local papers and are online for anyone who cares enough to look. The commenter feels that this proposed new requirement to prominently display each school's rating is an effort to inform the public of the school's performance, most parents/guardians won't understand the criteria for

scoring and the different areas that are measured. The commenter states that if KDE wants to help parents/guardians to become better informed, they should hold public meetings to explain the different aspects of the actual method of measurement so that when their student's school district releases ratings, they will understand what it actually means.

(b) Response: The agency carefully reviewed and considered all comments.

KRS 158.6453 (17) states that the Kentucky Board of Education shall promulgate an administrative regulation under KRS Chapter 13A to establish a reporting structure for assessments. The statute states that the reporting structure include a school report card that clearly communicates with parents and the public about school performance. The school report card shall be sent to the parents of the students of the districts, and information on electronic access to a summary of the results for the district shall be published in the newspaper with the largest circulation in the county. To meet the requirement that the school report card must be sent to parents, the unique URL to the school's report card may be shared with parents through electronic communication or paper format. The requirement that districts share information on electronic access also can be met by publishing the URL in the newspaper with the largest circulation in the county.

School and district report cards provide information about each school district, including test performance, teacher qualifications, student safety, awards, parent involvement and much more. School report cards help open the lines of communication between the school, the homes of its students and its local community. Parents can use school report cards when they visit their child's school for conferences and other meetings.

Since 2018, the KDE has been working collaboratively with a school report card vendor, BrightBytes, to develop an online school report card that meets both federal and state requirements. Since the beginning of development, KDE and BrightBytes have worked together to make the report card user friendly to all stakeholders, including parents, and have been working on various enhancements each year to meet the needs of all viewers.

After careful consideration, the agency agrees to amend the regulation by removing the proposed new section, Section 5, in its entirety. The proposed added reporting is comparable to the requirements of the SRC previously established in Kentucky statute. Requiring schools to do similar reporting is unnecessary. Beyond the school report card state-level requirements, districts and schools continue to have ability to hold meetings and distribute information about performance on assessment and accountability results. The agency will continue to enhance the school report card and provide districts and schools with the resources needed to communicate results.

(2) Subject Matter: Reporting of Assaults on Teachers, Staff, and Students.

(a) Comments: The commenter states, "I would like to see the number of assaults on teachers, staff, and students to be reported." The commenter also states that "school assaults are being swept under-the-rug by school districts" and challenges "the Department of Education to really discover how many teachers are getting beat up in the classroom by little kids who do not know how to behave."

The commenter included several additional observations and comments that did not directly relate to the School Report Regulation.

(b) Response: The agency carefully reviewed the comments.

As proposed, 703 KAR 5:140, Section 2(5)(d) requires a school report card include, among other items, "data detailing school safety incidents reported pursuant to...KRS 158.444." KRS 158.444 requires the Kentucky Department of Education "establish and maintain a statewide data collection system" and requires districts report within such system "all incidents of violence and assault against school employees and students."

Accordingly, the Kentucky Department of Education collects, pursuant to KRS 158.444, and publicly reports data on assaults, including incidents of "Assault, 1st Degree" as well as "Other Assault or Violence," which includes, for example, Abuse of a Teacher as established in KRS 161.190. Publicly reported student behavior incidents are available within each school, district, and statewide School Report Card and, as required by KRS 158.444, are disaggregated by "sex, race, and grade level."

No amendments have been made in response to this comment.

Summary of Statement of Consideration And Action Taken by Promulgating Administrative Body

A public hearing was scheduled for the above regulation on February 24, 2020 at 10:00 a.m. Eastern Time at the Kentucky Department of Education, 300 Sower Boulevard, Frankfort, Kentucky, but was cancelled because no one registered to attend. Written comments were accepted through February 29, 2020. The agency responded to the comments and amends the regulation as follows:

- (c) The superintendent of the local education agency shall determine whether each public elementary and secondary school shall display the school's current federal and state accountability classification in a prominent location or conduct an advertised public meeting to discuss the school's current federal and state accountability classification and plan for sustainability or improvement.
- (2) Each school shall provide written or an electronic form of notification within 30 days of public release of data to the parent or legal guardian of any student who attends that school. The written or an electronic form of notification shall include the current federal and state accountability school classification which includes a graphic of the star ratings, include the link to the school report card and may include additional information such as school programs.
- (3) In case of a change to the school's federal and state accountability classification, schools shall update the display or conduct an advertised public meeting and provide written or an electronic form of notification to the parent or legal guardian."
