- Assistant Principal The assistant principal position is vital to the success, culture, and operations of the Newport Intermediate School. The necessity to support student growth, teacher development, and addressing the needs of the school's operations are significant tasks that cannot be completed by one individual.
- Counselor #1 The counselor role is necessary to address the social, emotional, and academic needs of our students. This role will continue to monitor provided supports, implement counseling programs and individual counseling as needed. The counselor will also coordinate the enrollment/transfer process for any or our students.
 - Priority #2 of the KDE Diagnostic Review
- Counselor #2 In addition the role description for Counselor #1, a second counselor is requested to support our special needs population. The amount of IEP's are increasing and needs are intensifying. The request for an additional counselor will help balance the responsibilities of the ARC chairperson and address the BAC needs in our school.
 - We have over 90 Students that receive special education services. Our current situation limits our counselor's ability to provide services due to the time consumption to address IEP needs, meetings, paperwork.
- Classroom teachers The request for additional classroom teachers allows us to reduce classroom sizes which
 impacts instructional effectiveness. As well, the addition of three teachers will create a teaming system of triads
 at each grade level to best implement an instructional program. This number allows our master schedule to be
 effective and efficient.
- Related Arts (Art, Music, PE, Media Specialist) These positions will allow our students the opportunity to
 continue receiving instruction in these specialized areas.
- Moving In the Morning Teachers (30 minutes) These positions allow for proper supervision and engagement
 during the early hours before school begins. The students are provided an opportunity to participate in physical
 activity prior to the start of the school day. This program currently serves 60-80 students daily.
- Behavior Intervention Teacher This role is necessary to implement our behavior intervention classroom. This room is used to provide support to students that may be struggling behaviorally or students that are disruptive in the regular setting. The person in this role provides strategies to students to help them become successful in the regular setting.
- Permanent Substitute Teachers (Rank V) Our school struggles to get subs on a consistent basis. This request gives us the opportunity to better maintain the integrity of instruction in the classrooms to avoid our teachers from splitting classrooms to address coverage. As of 3-20-20, only 25% of all substitute teacher requests were met via Frontline (Aesop). 75% of the time, classes were split and class sizes were at capacity.
- ELL Teacher Due to increasing numbers of ELL students, we are requesting a full time ELL certified teacher to assist with instruction. Currently we have at least 70 ELL students and that number will increase with our incoming 3rd grade students.
- Alternative Placement Teacher- Based on Priority 2 and supporting the special needs of our students, we believe
 we need to provide learning opportunities and environment to maximize impact on student achievement and
 growth. After evaluation of current services and resources we have identified the next level of specialized
 student need to be an alternative placement service within our school building.
