I. Call to Order

Chairman Joe Ray Thornbury called the meeting to order at 6:00 pm.

III. Student Achievement

A. Student/Staff Recognition

B. PHS SBDM/Principal's Report

Principal Jason Booher recognized members of the High School's Site Base Decision Making Council, updates on the transition to on-line learning due to the state of emergency related to the COVID-19 Coronavirus, earning of Premier Delegation Status and Best New Delegation by our Kentucky United Nations Assembly (KUNA) student group who participated as a representative of the Vatican City in a simulation in international diplomacy held in Louisville, All Distinguished district ratings by our junior high and high school bands, cancellation of state academic team and MathCounts competitions, Harrison Booher's receipt of the KHSAA Sweet Sixteen Whitaker Bank and Georgetown College's Distinguished Alumni Scholarships, Kaila Zacarias's receipt of Morehead State University's Diversity Scholarship, opening of Pikeville Independent Alumni and Community Scholarship applications, postponement of April ACT test date, renovations to the entrance trophy case and the wall of fame in the commons area, KHSAA imposed dead period due to COVID-19 social distancing concerns, girls basketball regional champions, boys basketball district champions, presentation on analysis of junior high and high school ACT student performance,

PHS Teacher and Chair of the English Department, Mrs. Rebecca King shared comments of appreciation for Superintendent Jerry Green's service to Pikeville Independent and well wishes for his upcoming retirement.

PHS Guidance Counselor, Dawn Stewart shared that Advanced Placement was exploring the option of providing students with online AP testing, the May SAT test date had been cancelled and co-presented with Mr. Booher regarding analysis of junior high and high school ACT student performance.

SBDM parent representative Lyle Blackburn, Chairman Joe Ray Thornbury and Superintendent Jerry Green shared comments of compliment and gratitude of the high school and its leadership.

D. Instructional Supervisors' Report

Instructional Supervisor Johnny Belcher gave compliments and gratitude to all staff in the district for their efforts in transition to on-line learning as well as meeting the challenges of many other obstacles in the crisis response to COVID-19 social distancing measures underway. He also shared that end of year state testing had not been cancelled, but it would not be unexpected, if it is announced in the near future.

District Technology Directors Neil Arnett and Brandon Blackburn presented details for how future Board Meetings might be held virtually.

Superintendent Jerry Green and Board Attorney Max Thompson shared details about recent guidance from the Kentucky School Boards Association regarding the open meetings law and virtual meetings.
