## Memorandum of Agreement

# Woodford County Board of Education Campbellsville University School of Education.

This Memorandum of Agreement (MOA), dated is for the purpose of creating a Master of Arts in School Improvement (MASI) program in partnership between the Woodford County Board of Education and the Campbellsville University School of Education. The MOA beginning July 1, 2020 and ending June 30, 2022 hereby contains the following provisions.

- The new MASI program called Woodford County/Campbellsville University Grow Your Own will be exclusively available to teachers who work in the Woodford County. Classes will be co-taught using the Campbellsville University School of Education curriculum and course pathways but through the "lens" of becoming a teacher leader in Woodford County Schools
- The program will consist of 10 eight-week bi-terms with students taking one class each term for a total of 30 hours. It is anticipated that five 10 students will participate in each cohort with each cohort progressing the entire course pathway before a new one begins.
- All classes will be co-taught at the Woodford County Middle School by Woodford County district administrative personnel and CU School of Education faculty except for those taught during the first and second summer bi-terms. During these terms, classes will be taught online by Campbellsville University School of Education faculty. All CU faculty and Woodford County personnel in order to teach classes must meet requirements as determined by Campbellsville University.

Accessories: GAME/TRAINING/TRAVEL/SIDELINE/STAFF

#### 4. Pricing:

During the term of this Agreement, Woodford Co. High School and Middle School agree to purchase adidas footwear, mi-team apparel and accessory products through Bumblebee Team Sports at 35% off retail catalog price.

During the term of this Agreement, Woodford Co. High School and Middle School agree to purchase adidas apparel products through Bumblebee Team Sports at 40% off retail catalog price.

\*Pricing for custom uniforms will be determined by School, BTS and adidas.

# 5. Promotional Products provided in exchange for exclusive product purchases as outlined above:

\$14,000 at retail catalog price of adidas promotional products in each year of agreement for the high school.

\$4,000 at retail catalog price of adidas promotional products in each year of agreement for the middle school.

\$5,000 at retail catalog price of adidas/Woodford County co-branded banners, media wall, signage, tablecloths, etc.

Promotional merchandise allocation is the sole responsibility of the ATHLETIC DIRECTOR.

Unused promotional merchandise amounts, as of 5:00 pm on June 30<sup>th</sup>, each year of this Agreement, are forfeited by Woodford Co. High School and Middle School . As a result, promotional merchandise cannot be carried from one school year to the next.

#### 6. Bonus compensation (merchandise):

\$1500 State Championship Promotional Product Bonus at adidas retail price.

- 7. Use of adidas Products: Exclusive athlete and staff use of adidas Products when engaged in athletic related activities.
- 8. All promotional products will be shipped blank and adidas is not responsible for embellishment costs on promotional items.
- 9. School is responsible for payment of all freight and/or shipping charges.

10. Disclaimer of Warranty: adidas shall not be liable to Woodford Co. High School and Middle School for any injury or damage suffered by Woodford Co. High School and Middle School from wearing or using adidas Products, except such injury or damage resulting from the gross negligence or willful misconduct of adidas. SPECIFICALLY WAIVES, ONLY AS AGAINST ADIDAS, ALL EXPRESS OR IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
