## **HISTORY/BACKGROUND:**

This is the first change order for the Secure Vestibule Entrances and Other Security Enhancements Project associated with Morel Construction Company. The original contract with Secure Vestibule Entrances and Other Security Enhancements Project was \$6,949,983.00. This change order for an additional \$1,643.00 with no previous change orders makes the new contract sum \$6,951,626.00.

Item No 1: Furnish and install revised camera types and locations at Woodland Middle School Special Needs Calming Rooms.

ADD: \$ 554.00

Item No 2: Furnish and install 22" LED monitor at Loading Dock/Kitchen Doors in lieu of 32" Display originally specified.

DEDUCT: \$3,229.00

Item No 3: Furnish and install two (2) additional cameras at RC Hinsdale Elementary School and one (1) additional camera at Turkey Foot Middle School.

ADD: \$4,004.00

Item No 4: Furnish and install drinking fountain shrouds at two (2) locations as required by permit review.

ADD: \$ 314.00
