Consider/Approve renewal of the Maintenance and Support Agreement with Idemia Identity & Security USA LLC., with permission to continue to renew the annual agreement as long as the Board is satisfied with the service and pricing does not increase more than the Consumer Price Index over a 12-month period.

HISTORY/BACKGROUND:

The Kenton County School District has partnered with Idemia Identity & Security USA LLC (Idemia) and the Kentucky State Police (KSP) since 2017 to electronically collect and process fingerprints for criminal background checks required by KRS 160.380. By renewing the agreement with Idemia, the District can continue to process background checks electronically, allowing for results to be received in 3 – 5 business days instead of the 12-week lead time when collected manually with ink, then mailed to KSP for processing. Idemia requires an annual renewal of their Maintenance and Support Agreement, and the District would prefer to renew annually as long as the Board is satisfied with the service and pricing does not increase more than the Consumer Price Index over a 12-month period.

FISCAL/BUDGETARY IMPACT:

\$1,962.00 annual renewal for 2020-21.

RECOMMENDATION:

It is recommended the Kenton County Board of Education approve the renewal of the Maintenance and Support Agreement with Idemia Identity & Security USA LLC., with permission to continue to renew the annual agreement as long as the Board is satisfied with the service and pricing does not increase more than the Consumer Price Index over a 12-month period.
