### Update on the Impacts & Implications of COVID-19 for the Kentucky Board of Education

# Monthly Update

- In response to the COVID-19 crisis, our focus at the Kentucky Department of Education has been three-fold – Educate, Feed and Support.
- We are committed to providing guidance and solutions that focus on educating and feeding our children and providing support to our districts.
- KDE Leadership meets three times a week to provide continued support; we also continue to hold weekly webcasts for superintendents on COVID-19 topics and information. These have been very well-received.
- March 2020 feeding numbers (includes breakfasts, lunches, suppers):
  - Note: Districts have until the 15th of each month to provide an update on meals they served the previous month.
  - 4,656,897 meals served to more than 230,000 children.
  - 230,000 children is our average daily participation.







# Timeline/Guidance

- Since our last update to KBE, we facilitated another call between our school superintendents/districts and the governor on April 20, in which he recommended the cancelation of in-person classes for the remainder of the 2019-2020 school year.
  - KDE issued the <u>COVID-19 Education Continuation Plan</u> on April 20, 2020, to maximize instruction during the COVID-19 pandemic while using non-traditional instruction (NTI) to reach 1,062 hours of instruction in all Kentucky school districts prior to May 29, 2020.
  - All school districts will have reached their 1,062 hours of instruction through NTI by May 29. Fayette and Jefferson counties will be the last two districts to finish.
- A series of waivers will remove barriers to educator preparation, certification and evaluation created by the COVID-19 emergency.



# **Timeline/Guidance**

- A series of waivers will remove barriers to educator preparation, certification and evaluation created by the COVID-19 emergency.
  - Prospective educators will not be required to take and pass a Praxis test either the Core Academic Skills for Educators tests or a Graduate Record Examinations test – for conditional admittance to an educator preparation program if they have met all other admission requirements. Most of those tests have been postponed by the provider, the Educational Testing Service (ETS), although some at-home testing options are becoming available.
  - Some of the required 70 days of student-teaching have been waived.
  - A waiver will allow university supervisors of student teachers to conduct observations remotely and the requirement of four observations also has been waived.
- Districts were given flexibility to make changes to their certified evaluation processes, procedures and timelines that affect all certified personnel for the 2019-2020 school year by <u>Senate Bill 177</u>



# Timeline/Guidance

- KDE issued guidance to districts on schools on Class of 2020 graduations alternatives and end of year procedures on April 30.
- The guidance was released after consulting and collaborating with the Kentucky Department for Public Health and the governor's office to ensure the options we shared with districts and questions we were asking them to consider will keep students, families and communities safe during the COVID-19 crisis.
- The documents <u>COVID-19 Emergency Guidelines for End-of-School Procedures</u> and <u>COVID-19 Emergency Guidelines for Graduation Ceremonies and Related Year-End Activities</u> provide options and offer questions districts should consider when making decisions about what kind of alternative graduation ceremony to have and letting students back into buildings to retrieve belongings and return school property.



# CARES Act Funding Guidance

- The CARES Act, which was signed into law March 27, allocates \$30.75 billion in emergency education funding to states.
  - Kentucky will receive about \$223 million an amount equal to about 4% of Kentucky's annual education budget – for K-12 education from two sources:
    - \$193.2 million from the Elementary and Secondary School Emergency Relief (ESSER) Fund, which is intended to provide local education agencies with emergency relief funds to address the impact of COVID-19 on elementary and secondary schools.
    - \$30 million of Kentucky's \$43.8 million share of the Governor's Emergency Education Relief (GEER) Fund, which is designed to enable the nation's governors to decide how best to meet their states' K-12 and higher education needs.
- KDE staff is currently working on guidance documents for our districts on both the GEER Fund and ESSER Fund. We expect to issue the GEER Fund guidance later this week or early next week. The ESSER guidance will follow about a week later.

## Guidance for start of 2020-2021 year

KDE is asking districts to be flexible as they consider their plans for the start of the next school year due to the COVID-19 crisis.

- We have advised districts to plan for multiple scenarios that might occur before and after the start of the 2020-21 year:
  - An early start, perhaps as early as late July;
  - A traditional start; and
  - A late start, perhaps after Labor Day.
- We have advised superintendents they might want to consider asking their local boards of education to approve multiple calendars to allow for the different scenarios.
- The resumption of in-person classes might come with a number of changes that will have to be made in the interest of the safety and health of students and staff members.
  - KDE's guidance documents will address these changes and will focus on what is best for Kentucky's students.
  - We currently are preparing these guidance documents; which are expected to be released no later than May 11.

## Communications Update: Continuing To Get Our Message Out

- Since we last updated KBE, the KDE Communications Office has continued to support schools, districts and students in a number of ways:
  - We hosted four more Special Superintendents' Webcasts, all on topics related to COVID-19. Each webcast offers Q & A, broadcasted publicly.
  - We published 22 news stories on <u>Kentucky Teacher</u> related to the COVID-19 crisis, including a feature story on how <u>teachers from the Kentucky School</u> for the Blind and Kentucky School for the Deaf personally delivered NTI <u>materials</u> to families across the state during the week of April 20, 2020.
  - It was another record-breaking month for *Kentucky Teacher*. We had almost 160,000 total page views on KT for April. And in just the first four months of 2020, we have had more than 408,000 total page views which is more views than we had for ALL of 2019. (For all of 2019, we had 381,000 total page views.)



### Getting Our Message Out: Social Media

We have used KDE's social media channels to live tweet virtual meetings and regularly communicate updates about the COVID-19 crisis.

- As expected, our metrics on Facebook and Twitter went down slightly in April because we saw substantial growth in March. The April numbers are still significantly higher than any previous month. The public was most interested in alternate schedules for 2020-2021, graduation guidance and Commissioner Brown's letters to families.
- We put a call out to all superintendents to submit up to 10 photos of their graduating class of 2020 for a few projects we are working on. We have received more than 2,000 photos from over 200 schools!




## Getting Our Message Out: Media & Press Releases

- Since April 8, 2020, the KDE Communications Office has:
  - Responded to more than 20 requests from local and national reporters and media outlets
  - Coordinated/conducted interviews with KDE staff with local and national media outlets regarding school closures, NTI, federal waivers and many other topics related to the crisis
  - Produced and sent out 29 press releases (14 related to COVID-19)
  - We are also working with the Lt. Governor's Office and a few special guests on a special video tribute to the Class of 2020 that will tentatively air the week before Memorial Day. We are very excited about this project.

- We wanted to virtually align all of the resources KDE is providing in one place.


