1. 2020-2021 - Commercial Insurance Coverage Renewal (Renewal attached)

-EM Ford and Company LLC for Liberty Mutual \$194,956

*@10% increase on Commercial Insurance Proposal due to overall increase in General Liability coverage in market and instability of rates in current situation

2. 2020-2021 - Workman's Compensation Coverage Renewal (Attached w/rating sheet)

-KEMI (Kentucky Employer Mutual Insurance) \$81,981.45

*Decrease from \$102,987 last year, due to index improved from 1.05 to .77

3. Cyber-coverage update - currently have the same amount of coverage of \$250,000 included in Commercial Insurance Renewal above. Additional coverage quote will be coming based on Tech conversations.
