"Bullying Reporting Procedures"

Encouraged use of online reporting system by switching items 2 and 3

Added language to include racial slurs and hate speech in bullying definition

## Page 15:

"Bullying Reporting and Procedures" (cont.)

Added sentence requiring schools to report ongoing issues of bullying to the district's Bullying Department

"Olweus Bullying Prevention Program"

Updated language on implementation

"School Based Decision Making School Bullying Policy"

Clarified that all schools are responsible for having a policy. Including schools without formal SBDM (AIS)

"Other District Programs/Resources"

Updated grade level language

"Suicide Prevention and Support"

Removed language regarding House Bill 30 and added language requirements from SB 1
Updated Resource List

Added language to include culturally responsive classroom climate

## Page 22:

"Bus and Transportation Support"

Added ECE language for conducting an ARC

"Progressive Discipline"

Updated examples of underlying problem examples

Expanded definition of "practitioners" to include Mental Health Practitioners, Psychologists, and the Admissions and Release Committee

Added ECE language for conducting an ARC

## Page 25:

"Behavior Resolutions and Definitions"

Added Threat Assessment Guidance clarifying use of mobile assessment

## Pages 26 and 27:

"Behavior Resolutions"

Removed repetitive use of Assault Code. Differences between staff and student are outlined within the KDE definitions. There is no need to differentiate between staff and student. Levels remain the same for both

Expanded profanity/vulgarity code to include Hate Speech and Racial Slurs

## Page 30:

"Behavior Definitions" (cont.)

Clarified "loitering on school grounds" code to include trespassing

Added definition to accompany Hate Speech and Racial Slurs

## Page 31:

"Behavior Definitions"

Updated Terroristic Threatening in the second degree to align with statutory update

## Page 33:

"Due Process"

Expanded definition of Due Process to align with Board Policy

## Page 36:

"Criminal Violations"

Removed use of SRO and updated to reflect language used in JCPS Security and Investigations

Added a paragraph for ECE clarification for the ARC Process

Changed "habitually absent" to "truant"

Changed from "must" to "may" require a written complaint
