STUDER EDUCATION UPDATE

Nannette Johnston with Studer Education was present to give the Board a year end update on the work completed with Studer Education for the 2019-2020 school year (a copy of which is attached to the minutes.)

**GOVERNORS EMERGENCY EDUCATION RELIEF FUND AND
ELEMENTARY AND SECONDARY SCHOOL EMERGENCY
RELIEF FUND**

Ms. Gemmill, Superintendent, made the Board aware of CARES (Coronavirus Aid Relief Economic Security Act) money. The Governor and the Kentucky Department of Education have agreed that all schools across Kentucky have been severely affected by COVID19 and consequently all school districts will receive these funds. Under the CARES Act there are two pots of money, the Governor's Education Emergency Relief Fund (GEER) and the Elementary and Secondary School Emergency Relief Fund (ESSR).

The GEER money is specifically for two areas of spending – remote learning (technology) and food service. The ESSR money gives the district a little more flexibility on the areas of

spending. Based upon the amount of money the district receives, Mr. Bentzel can prioritize which of the allowable expenses would be the best use of the money for Christian County. Some examples of allowable spending under the ESSR fund include: summer learning, professional development, sanitizers, thermometers, masks, etc.

The District is expected to receive a little over \$500,000 in GEER funding and \$3,000,000 in ESSR funding.

Mr. Bentzel and Jessica Darnell will give the Board a more specific update at the June Board meeting.

ORGANIZATIONAL CHART UPDATE

Mr. Bentzel presented to the Board his proposed Organizational Chart for Central Office (a copy of which is attached to the minutes.) He noted all his proposed changes, renaming of positions, addition of positions and restructuring. He noted that the positions that were removed and the positions that were added is financially balanced and no additional spending is required.
