Thereupon, after discussion of the use of General Fund revenues toward payment of the costs of school building construction projects or debt service on bonds issued to finance construction projects, a motion was made and seconded that the following Resolution be adopted:

A RESOLUTION OF THE BOARD OF EDUCATION OF THE  
WOODFORD COUNTY SCHOOL DISTRICT AUTHORIZING  
THE USE OF \$\_\_\_\_\_ FOR FISCAL YEAR  
2020-2021 OF GENERAL FUND REVENUES FOR DEPOSIT  
INTO THE BUILDING FUND FOR USE TOWARD THE  
PAYMENT OF THE COSTS OF CONSTRUCTION PROJECTS  
OR DEBT SERVICE ON SCHOOL BUILDING REVENUE  
BONDS ISSUED TO FINANCE SCHOOL BUILDING  
CONSTRUCTION PROJECTS.

WHEREAS, the Board of Education (“Board”) of the Woodford County School District (the “District”) desires to undertake the acquisition, construction, installation and equipping of school building improvements within the District (“Construction Projects”) and to direct the Woodford County School District Finance Corporation (“Corporation”) to issue school building revenue bonds (“Bonds”) in order to finance all or a portion of the costs of such Construction Projects; and

WHEREAS, the Board has determined that the dedicated sources of revenue for payment of the costs of such Construction Projects or debt service on Bonds would not be sufficient and it is therefore necessary and desirable for the Board to supplement such dedicated sources of revenue with \$\_\_\_\_\_ of revenues from the school district’s General Fund for deposit into the Building Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE WOODFORD COUNTY SCHOOL DISTRICT:

That the Board hereby authorizes the use of \$\_\_\_\_\_ of General Fund revenues for fiscal year 2020-2021, ~~for~~to pay the costs of the Construction Projects and or to make necessary lease payments to the Corporation to be used by the Corporation toward debt service on Bonds issued to finance the Construction Projects.
