WHEREAS, the Board has determined that the dedicated sources of revenue for payment of the costs of such Construction Projects or debt service on Bonds would not be sufficient and it is therefore necessary and desirable for the Board to supplement such dedicated sources of revenue with \$_____ of revenues from the school district's General Fund for deposit into the Building Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE WOODFORD COUNTY SCHOOL DISTRICT:
