**APPLICABLE BOARD POLICY:**

**HISTORY/BACKGROUND:**

KCSD and BCS approved a MOU for 2019-20 and again for the 2020-21 for the partnership of the Ignite Institute. As Ignite grows additional staffing is needed. The Addendum to the MOU is for position for a School Resource Officer (SRO) to meet the safety needs. The SRO will be provided by the Boone County Sheriff's Office in accordance with its existing School Resource Officer Agreement with BCS.

**FISCAL/BUDGETARY IMPACT:**

KCSD will reimburse BCS for one-half (1/2) the cost of the SRO, not to exceed \$42,500.00 for the 2019-2020 school year, and for the 2020-2021 school year, not to exceed \$42,500.00. This SRO Addendum shall remain in effect year to year, with adjustments to KCSD maximum contribution if needed, until terminated with 90 days' notice by either party.

**SRO ADDENDUM  
TO  
MEMORANDUM OF UNDERSTANDING  
BETWEEN  
KENTON COUNTY SCHOOL DISTRICT

Being to their mutual benefit, Kenton County School District (KC) and Boone County School District (BC), agree as follows:

1. A position for a School Resource Officer (SRO) is established at the Ignite Institute for the 2019-2020 school year.
2. The SRO will be provided by the Boone County Sheriff's Office in accordance with its existing School Resource Officer Agreement with BC.
