- 6 RELATES TO: KRS 156.101
- 7 STATUTORY AUTHORITY: KRS 156.029(7), 156.070, 156.101
- 8 NECESSITY, FUNCTION, AND CONFORMITY: KRS 156.029(7) requires the Board of Education to
- 9 develop policies and to promulgate administrative regulations by which the Department of Education
- shall be governed. KRS 156.070 authorizes the Board of Education to promulgate administrative regula-
- tions necessary for the efficient management, control, and operation of the schools and programs under
- its jurisdiction. KRS 156.101 requires the Kentucky Board of Education to establish specific criteria for
- implementing a statewide instructional leader improvement program for employees of the public schools
- holding valid certificates and performing responsibilities in a position for which administration certifica-
- tion is required by the Education Professional Standards Board pursuant to 704 KAR Chapter 20. This
- administrative regulation establishes criteria for the program.
- Section 1. Definitions. (1) "Conference" means a scheduled professional training opportunity, sponsored
- by a state or national educational organization or a training provider, at which a variety of instructional
- leadership topics are available for participant attendance.
- 20 (2) "Cycle" means a twenty-four (24) month period beginning with July 1 of even-numbered years and
- 21 ending June 30 of even-numbered years.

- 1 (3) "School year" means a twelve (12) month period beginning July 1 and ending June 30.
- 2 (4) "Training provider" means an established educational organization, local school district, or private
- 3 educational consultant who sponsors training programs.
- 4 Section 2. (1) Participation in the program shall be required for a certified and employed instructional
- 5 leader.
- 6 (2) To fulfill the requirements of KRS 156.101, an instructional leader shall obtain the approval of the lo-
- 7 cal superintendent or designee if selecting specific training offerings from the state-approved directory or
- 8 if attending education-related conferences.
- 9 (3)[(a) Until June 30, 2006, every two (2) years, a local school district shall send a verification
- statement to the Kentucky Department of Education and the Education Professional Standards
- 11 Board, recording the names of all instructional leaders, their position titles, their Social Security
- 12 numbers, the dates they entered the two (2) year cycle, and the number of hours of training ob-
- 13 tained during the two (2) year cycle.
- (b) [Beginning July 1, 2006, a local district shall keep on file documentation of compliance with KRS
- 15 156.101(4) for each instructional leader employed by the school district, including a copy of all training
- certificates. Beginning August 30, 2007 and by August 30 each year thereafter, the local school district
- shall report to the Kentucky Department of Education the name of any instructional leader who fails to
- complete the twenty-one (21) hours of training required under KRS 156.101, the individual's position ti-
- tle, Social Security number, and the number of hours which were completed.
- 20 (4) All certificates shall be kept on file for three (3) years by each local district for each participant. If a
- 21 participant becomes employed by another district, the original file shall be sent to the instructional leader
- and a duplicate copy to the new employing district.
- Section 3. (1) Instructional leaders shall participate in a training program designed to improve and main-
- tain the quality and effectiveness of instructional leadership in the public schools of the Commonwealth.

- 1 Agencies, institutions, education cooperatives, local school districts, and private educational consultants
- 2 who qualify as training providers may be approved by the Kentucky Department of Education to design,
- 3 implement, and evaluate the training. Specific training approved within the program by the Department
- 4 of Education shall be:
- 5 (a) Intensive and designed specifically for instructional leaders. Participation shall occur during the con-
- 6 tract period including extended employment, if applicable. Training shall be scheduled so as to minimize
- 7 disruption of the instructional program of the district;
- 8 (b) Competency-based, specifying the instructional leadership competencies to be mastered by partici-
- 9 pants. Competencies shall have applicability for improving the effectiveness of the instructional leader or
- be role-specific. The design of the activities shall consider the participant's stage of professional devel-
- 11 opment;
- 12 (c) Comprehensive in nature and shall meet identified needs based upon the personnel evaluation, the in-
- dividual professional growth plan, and self-assessments of the instructional leaders; and
- 14 (d) Evaluated for approval in terms of program content, instructional processes, and impact upon partici-
- 15 pants.
- 16 (2)(a) An instructional leader may count attendance at education conferences up to six (6) hours of credit
- each school year. An instructional leader shall provide verification of attendance at education confer-
- ences to be filed with the local school district.
- 19 (b) An instructional leader shall receive three (3) participant-hours credit for duties performed by serving
- on one (1) beginning teacher committee established under KRS 161.030(6), and the instructional leader
- shall receive a maximum six (6) hours if the individual serves on more than one (1) committee.
- 22 (3)[(a) Until June 30, 2006, an instructional leader whose effective date of employment is within the
- 23 second half of a school year shall complete a prorated requirement of twenty-one (21) hours of
- 24 **leadership training.**

- 1 (b) If an instructional leader is employed for 100 days in the same position during a school year, the in-
- 2 dividual shall complete the required training.
- 3 (4) A participant's verification of attendance at approved Effective Instructional Leadership Training ses-
- 4 sions and programs and copies of program certificates shall be recorded with the professional develop-
- 5 ment coordinator of the instructional leader's school district no later than June 30 of each year.
- 6 (5) Excess hours, not to exceed twelve (12) earned by a participant during the thirty (30) day period of
- 7 June 1 through June 30, may be credited toward required hours for the next school year.
- 8 Section 4. The training program content shall consist of specific competencies identified in the **Profes-**
- 9 sional Standards for Educational Leaders as incorporated by reference in 704 KAR
- 10 3:370[Standards and Indicators for School Improvement established in 703 KAR 5:120].
- 11 Section 5. The training provider shall:
- 12 (1) Develop programs that meet all the criteria identified in Sections 3 and 4 of this administrative regula-
- 13 tion;
- 14 (2) Select program faculty who have adequate, pertinent training and education, appropriate experience,
- and the ability to instruct effectively;
- 16 (3) Meet identified needs consistent with those listed in the **Professional Standards for Educational**
- Leaders as incorporated by reference in 704 KAR 3:370[Standards and Indicators for School Im-
- 18 **provement established in 703 KAR 5:120**];
- 19 (4) Conduct training as set forth in its proposal and as approved by the Kentucky Department of Educa-
- 20 tion;
- 21 (5) Award a participant a certificate of attendance that includes the providers approval number and the
- 22 number of hours completed; and
- 23 (6) Evaluate the training in terms of its content, instructional processes, impact upon the professional be-
- havior of participants, and improved student learning.

- 1 Section 6. (1) The Department of Education shall approve training activities and providers, and maintain
- 2 and communicate a directory of approved activities and providers.
- 3 (2) The Department of Education may revoke the approval of any training program not in compliance
- 4 with this administrative regulation and may delete the program.
- 5 Section 7. (1) Approval of a training program shall be granted for a period of one (1) year.
- 6 (2) Approval as a provider shall be based upon:
- 7 (a) Submission of a provider's training program proposal to the Department of Education at least thirty
- 8 (30) days prior to the initial presentation of the training activity; and
- 9 (b) Content consistent with the **Professional Standards for Educational Leaders as incorporated by**
- reference in 704 KAR 3:370[Standards and Indicators for School Improvement established in 703
- 11 **KAR 5:120**].
