#### Discussion:

Mrs. Marganna Stanley reviewed with the Board the following recommended ways to deliver instruction which will likely be used throughout the upcoming school year: 1. Inperson class, 2. Virtual Learning Academy (parent choice), 3. Non-traditional Instruction (NTI), and 4. Hybrid (students attend school 1 or 2 days a week and use NTI 2 to 3 days a week). Mrs. Stanley recommended, as of July 16, 2020, to open school with In-person class instruction. Mr. Kirk Haynes shared his concern with the earlier start time for school employees who need to drop off their children at the same time they are to report to their

work site. Mrs. Stanley said that principals have already started to address that individually and are working with our employees to swap out duties as needed to be as accommodating as we can. Mrs. Tracey Williams said that a middle school parent contacted her and was not sure if middle school students were required to have the COVID testing, however, Mrs. Williams understood that no matter the age, a COVID test is required for any student participating in sports. Mrs. Stanley clarified that all students participating in any extracurricular activity (sports, band, choir, etc...), are required to have a COVID test.

**Order #4 - Motion Passed:** As of July 16, 2020, the Superintendent recommended reopening school with In-person class Instruction. A motion to accept all four (4) reopening plans as presented with the Superintendent to use whatever option is needed based on whatever situation may arise passed with a motion by Mr. Michael Waller and a second by Mrs. Tracey Williams.
