# **Division 07: Thermal and Moisture Protection**

07.01: 2020.07.14 – Fire safing and caulking was observed at the entry corridor at Ryland Heights.

## **Division 08: Doors and Windows**

08.01: 2020.07.14 – Door hardware installation was actively occurring at Beechgrove. Work was complete at Ryland and Hinsdale for mechanical hardware.

08.02: 2020.07.14 – All safety film installation and corrections were complete except for River Ridge. Summit View had been prepped for perimeter seal installation, which was scheduled to begin that day.

# **Division 09: Finishes**

09.01: 2020.07.07 – Soffits, fascias, and infill walls were framed and boarded at Hinsdale. Finish paint appeared complete on walls and frames.

09.02: 2020.07.14 – Finish paint appeared complete on walls and frames at River Ridge. Ceiling grid was complete. Ceiling tiles were 95% complete in the Media Center.

09.03: 2020.07.14 - Ceiling grid installation was actively occurring in the Media Center at Hinsdale. Installation at corridors and alcoves appeared complete.

09.04: 2020.07.14 – Walls had received drywall at Ryland Heights. Walls and frames had been painted in half of the split admin suite.

#### **Division 10: Specialties**

10.01: 2020.07.14 – The Car Rider Pro sensing stations had been installed at all but White's Tower. The unit at Hinsdale was identified as being out of plumb and needing correction.

#### Division 20-28: MEP

20-28.01: 2020.07.07 – Termination of ESS cabling was underway in the MDF at Hinsdale. 20-28.02: 2020.07.14 – Camera installation at River Ridge appeared complete. Access control wiring installation at River Ridge had been terminated at the control panel. The electrician was actively installing light fixtures in the lobby.

20-28.03: 2020.07.14 – DAS installation was wrapping up at Hinsdale. Drinking fountains had been installed there as well.

20-28.04: 2020.07.14 – Drinking fountains were staged for installation at Ryland. Camera installation appeared complete.

20-28.05: 2020.07.14 – The electrical subcontractor was actively pulling service cable into the electric room to the new switchgear.

20-28.06: 2020.07.14 – Access control coordination meetings with school staff for the balance of early completion schools took place between the access control contractor, the Owner, and site staff. 20-28.07: 2020.07.22 – The Contractor was notified Ryland HVAC equipment that was set to ship 7/31 now has a tentative ship date of 8/21. Delay appears to be COVID related.

## **Division 31: Earthwork**

31.01: 2020.06.25 – The earthwork contractor was actively grading the new parking lot near the mobile classroom units at White's Tower.

31.02: 2020.07.14 – The earthwork contractor had distributed top soil. Subgrade correction was yet to occur. 31.03: 2020.07.17 – It was conveyed to the contractor that an event is occurring at the fair grounds requiring the pavement work at the widened drive be complete before 8/1.

#### **Division 32: Exterior Improvements**

32.01: 2020.07.08 – Fencing punch list for the project was issued, along with a Request for Proposal to enlarge an opening at Piner for vehicle access and add a gate at Kenton Elementary for student management.






