HISTORY/BACKGROUND:

Conscious Discipline is an evidence-based, trauma-informed approach. The Board approved the Conscious Discipline Agreement to provide professional development and coaching for the 20-21 school year at a prior meeting. \$50,680 – CCEIS Special Education Fund


