**HISTORY/BACKGROUND:**

Acellus provides a comprehensive virtual learning curriculum for K-5. KCSD has approximately 5428 scholars in K-5 FOR THE 2020-21 school year. Acellus will allow parents the VL option due to COVID.

**FISCAL/BUDGETARY IMPACT:**

KCSD cost is based on predicting 770 K-5 scholars select VL as their 2020-21 option. The KCSD Parent Survey had 752 signed up as of 7/30/20. Each individual license is \$100.00. The cost will be \$77000.00 plus \$1500.00 for training of 15 teachers. Any unused licenses will be pending credit towards the next school year. Total price \$78500.00


