Waiver Request for Art Classroom

Mr. Bauman:

Your letter dated July 1, 2020 regarding the Design Development Phase for the New 800-Student Elementary School in Bullitt County indicates that the art classroom has no natural light and does not comply with 702 KAR 4:170, Facility Programming and Construction Criteria guidelines. The recommendation was to move the art room to the music room location and add an exterior door.

BCPS has been resistant to adding another door (i.e., control point) at the Art Room; therefore an exterior door was not shown.

The Art Room location and configuration were proposed with the following in mind:

- The Art Room has a large glazed wall opening to the daylit atrium. It is anticipated that activity from the Art Room can be visible from and spill out into the atrium and activate this central space in the school. The school expects that students from art classes will collaborate on stage sets for performances in this space and in the gym.
- Clerestories on multiple sides of the Atrium, allowing daylight to reach the Art Room through its large glazed wall, supplement the natural light from the large windows (13' wide) in the Art Room itself.
- Access to the outdoors is made very easy via doors directly out of the atrium onto a courtyard space designed for outdoor gathering and activities.
- Reversing the art and music rooms and providing an outside door would prove problematic from a site grading/drainage standpoint. There are also concerns about supervision of a patio that would be directly adjacent to a retaining wall to the north and the bus loading area to the east.

702 KAR 4:170, Part 2, section b.7.1, <u>Location</u> states the art classroom unit shall be "On the ground floor at north exterior wall for direct access to a future art patio".

With the art classroom currently designed with large glazed openings to borrow natural light (including diffuse light from the north) from the Atrium, as well as easy access to the courtyard directly outside the Atrium, the district requests a waiver from relocation of this space and provision of the exterior door.
