### **Grading Guidelines**



Recommended by a subset of the district SPP&G committee

Designed to support teachers and schools in taking steps toward a more mastery, standards-based approach while still providing a choice

Suggest teachers consider less emphasis on engagement and more emphasis on progress toward and mastery of standards

Emphasize providing ongoing, descriptive feedback that allows students to continue to improve rather than focusing on assigning a grade

Include consistent practices to be followed district-wide

### Are there Limitations on Competitors in Various Sports?

"Yes.

In an effort to help ensure appropriate social distancing, several restrictions and adaptations were approved for the fall sports."

- Field hockey and soccer: 24 players in uniform and participating in warm-ups and competition
- Volleyball: 15 players in uniform and participating in warm-ups and competition
- Cross Country: 10 runners, the current postseason roster limitation (additional runners may possibly be allowed depending upon future decisions)
- Football: 60 players in uniform and participating in warm-ups and competitions

## When will fall postseason adjustments/revisions/plans be made?

"Currently, those decisions will be finalized at the September Board of Control Meeting. If action takes place prior to that time, the membership will be notified. As of now, the guidelines to return to play will need to be continually monitored and under review. Our efforts are focused on the finalization of the Healthy at Sport Guidance to be in place on or before August 24."

## Can we schedule freshmen, JV, Varsity contests on the same night if we space out and clean?

- "The final determination will be made with the Healthy at Sport document and its release prior to August 24.
- At this point, consideration should be taken with regard to scheduling to minimize exposure and allow for sanitation between contests."

### Athletics: Current Information from KHSAA

- "It's advisable to initially limit to one contest per night and only extend to multiple contests when the same set of schools is involved in all games.
   Even then, there should be time between games for the sanitization of equipment and restrooms.
- Where additional schools are involved, there must be time between contests for egress of fans and participants, sanitization of equipment and restrooms, ingress of the teams for the next game.
- Consideration should also be given in large roaster sports to holding Varsity, Junior Varsity, and Freshman contests on separate nights."
