Scope

Provide a Complete Narrative of the Proposed Project

Security upgrades at all school centers to include access control system on all interior and exterior doors, security camera systems, addition of corridor doors at both high school and lower elementary. Construct secure entry and vestibule, upgrade original building first and

second floor restrooms to include water pressure upgrades, energy efficient lighting and plumbing fistures at high school.

School Security Funds:

As part of the Gallatin County High School renovation to create a security vestibule three main entrance electroic locks were required. One functioned at the primary entry door, one allowed access into the office from the vestibule and one allowed direct access from the vestibule into the main building corridor. All main entrance electronic locks are controlled by office personnel and/or through badged access.

Additionally as part of the security vestibule upgrades <u>main entrance camera and intercoms (1 each)</u> were provided that allow staff to monitor all three doors (approach, access to office, access to main corridor) and communicate with visitors upon arrival.

Gallatin County High lacked several common classroom lock security considerations and had numerous keying issues and duplicate keys accessible in the community. In an effort to better secure the building and classrooms all <u>214 interior classroom and 19 exterior entry doors</u> were replaced and rekeyed, new electronic locks with badged access control were provided at all exterior doors and all classroom doors.
