III. Reopening of School Programs

III.A. Instruction

Discussion:

Mrs. Marganna Stanley updated the Board on the current non-traditional instruction that is going on throughout the District. Mrs. Stanley shared the instructional plan for September 2020 which includes bringing in small groups of students and starting the Hybrid Schedule on September 28th. The small groups are by invitation and are for students in need of

extra help as defined in the guidance document from the Kentucky Department of Education. There was mention from some of the Board to start the Hybrid Schedule on September 21st. Mr. Mike Waller reminded everyone that the Board gave the Superintendent the approval at a prior meeting to use whatever option is needed based on whatever situation may arise. Mr. Kirk Haynes asked for the data on how the groups for the Hybrid Schedule are broken down to ensure an equitable and diverse plan.

III.B. Athletics

Discussion:

Dr. Bob Lawson presented the High School and Middle School Fall Sports Proposal for consideration by the Board for approval. Mrs. Lisa Baird asked for each Board Member to share their thoughts on starting athletics as presented. Mr. Mike Waller said that the proposal is great, however, he stated that the Board has the right to review and/or modify any proposals from KHSAA. Mr. Waller also requested to minimize the potential for exposure. He stated that we should let them try and, if there is a problem, then we need to shut it down. Mr. Kirk Haynes complimented the administration on putting academics first and said to let them play. Mr. Wes Smith said to let them play. He did suggest, however, to rearrange senior night sooner than later since we don't know what the future holds. Mrs. Tracey Williams said that, as a teacher, instruction in the classroom always comes before we allow our children to play sports, however, she will vote for them to begin. Mrs. Baird said that she supports letting them play, however, if things go wrong then we will have to shut it down. Dr. Lawson said that the way we will begin high school athletics, with the KHSAA guidelines, we would move middle school athletics back to the 17th. At this point we would not have elementary athletics. Mrs. Marganna Stanley mentioned that extra-curricular activities such as band, arts, and FFA would be afforded the same opportunities as athletics.
