Proposal 11 - Existing Panels LP1, LP2 and LP3 were mislabeled and found to be one phase during construction. This Change Order is for changing from 120/240v 1-phase to 120/208v 3-phase. ADD \$3,130

Proposal 12 - During construction it was determined that it would be economically feasible to replace an aged fence around the gas valve meter. ADD \$2,806

Proposal 13 - This Change order is for removing some exterior conduit and refeeding a light on southwest corner of building. Once under construction, it was determined that there was the opportunity to clean up some of the conduits and correct an older section of conduit at a very reasonable price. ADD \$3,771
