The Board of Education is charged with the development of a four (4) year District Facilities Plan. This committee studies information concerning the district's buildings, financial information, demographics, and other information at its discretion to develop a plan for addressing the district's capital construction needs.

Approve the proposed Local Planning Committee (LPC) for the development of the District Facility Plan (DFP).


