Disclosure of Free and Reduced Price Information Agreement

The Disclosure of Free and Reduced Price Information Agreement permits School Food Service to share eligibility information of students to BCPS employees. This information is considered highly confidential and can only be made available to those identified in the agreement as having a "need to know" in order to perform their job. Prior to School Food Service providing any confidential information, BCPS employees identified in the agreement are required to sign an Employee Affidavit of Nondisclosure form which states they agree to keep all student free and reduced price meal eligibility information confidential.

DISCLOSURE OF FREE AND REDUCED PRICE INFORMATION AGREEMENT

I. PURPOSE AND SCOPE

Bullitt County School Nutrition Service Program and Bullitt County Board of Education acknowledge and agree that children's free and reduced price meal and free milk eligibility information obtained under provisions of the Richard B. Russell National School Lunch Act (42 USC 1751 et. seq.) (NSLA) or Child Nutrition Act of 1966 (42 USC 1771 et. seq.) (CNA) and the regulations implementing these Acts is confidential information. This Agreement is intended to ensure that any information disclosed by the Bullitt County School Nutrition Service Program to the Bullitt County Board of Education about children eligible for free and reduced price meals or free milk will be used only for purposes specified in this Agreement and that the Bullitt County School Nutrition Service and Bullitt County Board of Education recognize that there are penalties for unauthorized disclosures of this eligibility information.

II. AUTHORITY

Section 9(b)(6)(A) of the NSLA (42 USC 1758(b)(6)(A)) authorizes the limited disclosure of children's free and reduced price meal or free milk eligibility information to specific programs or individuals, without prior parent/guardian consent. Except that, the parent/guardian must be provided the opportunity to decline to share eligibility information prior to the disclosure for identifying children eligible for benefits under or enrolling children in the State Medicaid Program and the State children's health insurance program. Additionally, the statute specifies that for any disclosures not authorized by the statute, the consent of children's parents/guardian must be obtained prior to the disclosure.

Note: Section 9(b)(6)(A) specifies that certain programs may receive children's eligibility status **only**, without parental consent. Parental consent must be obtained to disclose any additional eligibility information. Section 9(b)(6)(A)(iv) specifies that for State Medicaid or SCHIP, parents must be notified and given opportunity to elect not to have information disclosed. Social security numbers may only be disclosed if households are given notice of the disclosure and the uses to be made of their social security numbers as required by Sec. 7 of the Privacy Act.

III. RESPONSIBILITIES

Bullitt County School Nutrition Services will:

When required, secure parents/guardians consent prior to any disclosure not authorized by the National School Lunch Act or any regulations under that Act, unless prior consent is secured by the receiving agency and made available to the determining agency;

For State Medicaid and KCHIP notify parents/guardians of potential disclosures and provide opportunity for parents/guardians to elect not to have information disclosed;

Disclose eligibility information only to persons directly connected to the administration or enforcement of programs authorized access under the National School Lunch Act or

regulations under the Act or to programs or services for which parents/guardians gave consent.

Bullitt County Board Of Education will:

Ensure that only persons who are directly connected with the administration or enforcement of the (Fee Waiver Application, ACT, SAT, Title 1, College Board AP, NCLB, ESS, ESL, FRYSC, KCCT, and Pre-School) and whose job responsibilities require use of the eligibility information will have access to children's eligibility information:

Counselors, Pre-school Coordinator, Pre-school Administrative Assistant, Pre-school Consultants, Pre-school Teachers, Student Information System Data Coordinator, District FRAM Coordinator, CEP School FRAM Coordinators, Superintendent, Administrative Assistant to Superintendent, Assistant Superintendents, Director of FRYSC, Coordinators of FRYSC, District McKinney-Vento Coordinator, Assistant to District McKinney-Vento Coordinator, Director of Assessment, Data, and Research, Secretary of Assessment, Data, and Research, Instructional Coaches, Data Managers-Middle and HIgh Schools, and the BCPS Grant Writer. Principals, Assistant Principals, and Access 24 employees will be approved on an as needed basis.

Inform all persons that have access to children's free and reduced price meal eligibility information that the information is confidential, that children's eligibility information must only be used for purposes specified above, and the penalties for unauthorized disclosures.

Protect the confidentiality of children's free and reduced price meal or free milk eligibility information as follows:

The Student Information System Data Coordinator (Tammy Tomes) and the District FRAM Coordinator (Jim Jackson) have restricted user rights. Only individuals identified above will have access to these rights. The School Nutrition Service Office will notify the Student Information System Data Coordinator or District FRAM Coordinator upon receiving a completed and approved non-disclosure affidavit. will only give rights to these individuals upon receiving a signed copy of this agreement.

Description of Procedures to Transfer Meal Eligibility Information (May be completed by either the determining agency or receiving agency)

Describe the procedures for transferring students' meal eligibility information from the determining agency to the requesting agency/program so as to limit the number of individuals who have access to the information.

Federal and State programs were identified that would need access to the student's meal eligibility information. Once these programs were identified, then it was determined "who" within these programs would be working with the data. The Student Information System Data Coordinator will only give rights to these individuals upon receiving a signed copy of this agreement.

IV. **EFFECTIVE DATES**

This agreement shall be effective from October 1, 2020 through September 30, 2021.

V. **PENALTIES**

Any person who publishes, divulges, discloses, or makes known in any manner, or to any extent nor authorized by Federal law (Section 9(b)(6)(C) of the National School Lunch Act; 42 USC 1758(b)(6)(C)) ir a regulation, any information about a child's eligibility for free and reduced price meals or free milk shall be fined nor more than \$1000 or imprisonment of not more that 1 year or both.

VI. SIGNATURES

The parties acknowledge that children's free and reduced price meal and free milk eligibility information my be used only for the specific purposes stated above; that unauthorized use of free and reduced price meal and free milk information or further disclosure to other persons or programs is prohibited and a violation of Federal law which may result in civil and criminal penalties.
