2. Student Achievement

a. Assessing Student Achievement

- How are we going to measure whether students are performing at grade level?
We use MAP testing and this is scheduled for September 21st.
- How often will it be reported the number of students who are not meeting grade level expectations? Reported three times a year after each assessment.
- How are those results being communicated to the appropriate students, parents and staff members? PLC, faculty meetings and students will be conferenced individually by staff members.
- What is being done to help the students who are not performing at grade level?
RTI- specifically this year we have Wednesdays available to invite the students in specific intervention. And how will the effectiveness of those efforts be tracked?
PLC's will look at this data as well as RTI data.
