## BALLYSHANNON MIDDLE SCHOOL (BG #15-279 / REH #129-1214-A)

Ballyshannon Middle is still in the final stages of closeout – we are down to one final issue that needs to be corrected as well as some final paperwork that still needs to be submitted. We are pushing for this to occur as soon as possible.

Once the final Application for Payment has been certified for payment, the BG-4 and BG-5 Contract and Project Closeout forms will be presented for approval at a future meeting.

## BOONE COUNTY HIGH SCHOOL - ADDITIONS AND RENOVATIONS (BG #20-183 / REH #129-120-A)

Bidding Documents are complete and this project is schedule to be advertised on October 1 with bids due October 22 for award at the November board meeting. The schedule is to start on the outside theater/band addition immediately upon award with the interior renovation of the existing auditorium over Summer 2021. The intent is to complete the project by the beginning of next school year.

## BOONE COUNTY SCHOOLS - TURF FIELDS (BG #20-184 / REH #129-120-B)

This project has been awarded to OHeil Site Solutions and initial preconstruction meetings have been held. The contractor is working on site staging, preliminary schedules have been identified, and submittals are in process with color selections being finalized.

## STEEPLECHASE ELEMENTARY SCHOOL (BG #19-078 / REH #129-1016)
