PRESENTATIONS:

**BACK TO SCHOOL AND REOPENING PLAN UPDATE** 

Chris Bentzel, Superintendent; Laura Morris, Assistant Superintendent of Administration and Zach Hibbs, District Assessment Coordinator, were present to give the Board an

update on the Back to School and Reopening Plan.

Ms. Morris started the presentation by stating CCPS currently has 8,500 total students enrolled with 2,897 currently in Virtual Learning Academy. Teachers and staff are reaching out to families to address any concerns and questions of students enrolled in VLA. All schools with in person instruction are following safe at school guidelines. District Administrators have been in the schools on numerous occasions and students are doing an amazing job wearing their masks and adhering to all the new guidelines. School leadership teams have done an amazing job getting our schools back in session. Weekly meetings are continuing with the Christian County Health Department and our partnership with them is strong. On Monday, Governor Beshear updated districts on new reporting requirements for COVID19 numbers per district. Christian County will be prepared to adhere to that new reporting requirement effective September 28.

Mr. Hibbs gave the board an update on local and state COVID-19 data. Mr. Hibbs stated he is also tracking data from counties who have opened to in-person and/or hybrid instruction over the last couple of weeks. Mr. Hibbs also gave the board a snapshot of active COVID-19 and/or persons who are quarantined that effect CCPS students and/or staff. CCPS currently has 24 active cases of COVID-19 and 188 persons quarantined.

Mr. Bentzel explained in detail a situation at HHS, CCHS and Indian Hills that caused several student quarantines. He feels they have mitigated each situation. Due to the CCHS and HHS situations, the decision was made to postpone the CCHS vs. HHS football game that was scheduled for tomorrow night. Mr. Bentzel stated that CCPS is ready to go to a non-traditional learning program at any time they may have to close schools due to an outbreak. He also stated if for any reason a school is closed to in-person instruction for a given amount of time, the district will also cancel all extracurricular activities for that school during that period. Mr. Bentzel stated the District also sent a letter out today to student athletes that states if a

student is under quarantine or a close contact to a positive case and they do not report it to the district – they will be removed from extracurricular activities for the remainder of the year.

# NEXT GENERATION SUPERINTENDENT EFFECTIVENESS STANDARDS: STANDARD 1

Chris Bentzel, Superintendent, was present to give the Board an update on his progress of Standard 1 on the Next Generation Superintendent Effectiveness Standards.

As a first year Superintendent, he must meet requirements of a Capstone presentation to the Board of Education in May. In that Capstone he must be evaluated on all seven leadership standards of the Next Generation Superintendent Effectiveness Standards. Every month Mr. Bentzel will highlight a different standard and go over evidence that he has been collecting. He reviewed Standard 1 – Strategic Leadership.

Mr. Bell – He is on a new community committee that is working on equity and diversity. The committee is just beginning its meetings and Mr. Bell will keep the Board updated on its work.

# MR. BELL

Mr. Bell stated he was excited about the "ALL IN" awards. He feels it is not just a slogan, but he can feel the momentum within the district. Staff are stepping up and making this new normal work. He thanked the Chamber of Commerce for being the "ALL IN" sponsor this month. Mr. Bell is happy that the board meetings are now streamed online – it gives transparency to the community. He is looking forward to the rescheduled HHS vs. CCHS football game on October 30.

# **MS. HAYES**

#### MS. KELLER

Ms. Keller thanked everyone for their hard and never ending work. Teachers are sometimes having double the work. Just remember that students are benefiting from everything we are doing and that is why we are here. She thanked the students for stepping up and complying with all the new regulations. Ms. Keller is excited as well about the "ALL IN" awards. One of the recipients of the award tonight, Melissa Adams, is the daughter of Martha Petty, who was Ms. Keller's teacher. Ms. Petty is now deceased but was a great educator and made lifelong connections with her students and it is clear that her

daughter Melissa is doing the same. She thanked Mr. Bentzel for his constant communication over the last couple of weeks and his complete transparency. We will keep moving forward, one day at a time and deal with situations as they arise.

# MR. BENTZEL

Mr. Bentzel thanked parents for their patience during this time. He understands parents are missing a lot – walking their students in school, taking pictures, etc. Mr. Bentzel thanked community members for all their support over the last several weeks. The Chamber of Commerce just completed their Back to School Staff Meals to every school site, including Virtual Learning Academy staff members. Mr. Bentzel thanked the Chamber for also being the first sponsor of the "ALL IN" recognitions and providing gift cards to the recipients. He also thanked the Health Department for their partnership. They have been instrumental in getting the students back into the classroom. He thanked Megan Kidd – she is working tirelessly on situations as they occur. Mr. Bentzel stated most importantly – the students have been phenomenal and they are the most important aspect of why we are doing what we are doing.
