1. Kelly Wallingford - WBON

Kelly Wallingford, Owner of Wallingford Broadcasting Company, addressed the Board. Mr. Wallingford presented his case to continue live streaming sporting events. He implored the Board to give him time to present an alternate offer and apologized for any misunderstandings.

2. Julian Tackett - Commissioner of KHSAA

Julian Tackett, Commissioner of Kentucky High School Athletic Association (KHSAA), joined the meeting remotely. Mr. Tackett, who sits on the NFHS board, explained how the program works. He stated that the games would be streamed nationally; the district would receive two (2) free cameras valued at \$2,500 each; and that boosters could sell season passes. The passes are sold monthly or annually for a fee. The Board asked numerous questions which Mr. Tackett answered.

3. Public Comments

Students and members of the community then addressed the Board regarding the live streaming of athletic events. Those addressing the Board included: Jon O'Hair, Peyton Maybrier, Mallorie York, Mia Hale, Will Isfort, Landon Napier, Don Richardson, William Hardy, and student representative Summer Evans.

4. HS/MS Principal and Athletic Director comments

High School Principal Josh Yost, Middle School Principal Andrea Williams and district Athletic Director Austin Moore addressed the Board. It was their consensus that the NFHS would benefit all sports, not just football and basketball.
