AGENDA ITEM (ACTION ITEM):

Student from Scott High School is requesting the Board waive policy 08.113 Graduation Requirements (The Board requires enrollment for eight (8) semesters or the equivalent for all high school students.), so they may enroll full-time at Xavier University for the spring semester. The student is on track to graduate successfully from Scott High School. The graduation plan includes completing classes at Scott High School and through Northern Kentucky University. Scott High School SBDM and Dr. Brennon Sapp, Principal, support the request from the family. This would allow the student to complete all required high school coursework by the end of December, 2017.

APPLICABLE BOARD POLICY:

08.113 Graduation Requirements - The Board requires enrollment for eight (8) semesters or the equivalent for all high school students.

HISTORY/BACKGROUND:

Students, with school support, have been provided the opportunity to not meet the 8 semester requirement. The student must have a compelling reason, ie. Military commitment, full-time college/university enrollment, for the recommendation to be put to the Board for consideration.

FISCAL/BUDGETARY IMPACT:

District will lose ADA funding for ½ year for student, approximately \$2000.

RECOMMENDATION:

It is recommended that the Board waive policy #08.113 and approve early graduation for a student at Scott High School.




