Corrective Action Plan Follow-Up Audit Update - Amy Dennes, Chief of Staff

Ms. Dennes presented an overview of the KDE CAP Follow-Up Audit that is currently underway. In preparation JCPS has uploaded thousands of pages of documents in response to their request list. KDE has been conducting interviews virtually over the previous two and a half weeks and will finish at the end of the week. The District feels that the follow-up is going well. KDE has 90 days to issue their report, however, Ms. Dennes is hopeful that it will be received by winter break.

NTI 2.0 Update – Amy Dennes, Chief of Staff; Dr. Staci Eddleman, Director, Title I/II/IV and Program Supports

Dr. Staci Eddleman, Director, Title I/II/IV and Program Supports, joined Ms. Dennes in presenting a broad overview of the District's planning and implementation of NTI 2.0 in the new school year.

The committee asked questions and received feedback on several aspects of the implementation including the impact on student and staff engagement, the backpack program, CTE, improved communications between parents and teachers, and students' emotional health.

ARMAC Metric Deck Discussion – James Rose
