Based on the work scope and additional information provided below, S&ME is at \$26,650.

The private locator is \$2500 of that. I also have \$1000 budgeted for the one test pit. Our corporate folks have really cracked down on only using excavators with all sorts of insurance which rules out a lot of the local guys plus adds paperwork (costs) to me. Also, there isn't an equipment rental place local or I'd think about just renting one and running it myself.

IF we don't have to use plywood to prevent damage to the field (just use a regular drill rig) then we're at \$20,500. Obviously we'd do what we can to not tear up the field. Mr. Lee said the field was holding water the other day after some rain which doesn't give me a warm and fuzzy about not at least making some light ruts.

Let me know if we're in the hunt and we can get a full proposal together.

Some questions came up during this proposal request.

We are revising the bid date to 12 pm on Wednesday November 4. If you can submit before then please do so.

#### In clarification of the RFP:

- 1. The infiltration test is to be a single-ring infiltration test.
- 2. The field is to be protected. No rutting or damage is permitted.
- 3. We've been told that bedrock is as little as 14" deep under the baseball infield, but that cannot be confirmed officially.
- 4. Existing bleacher construction appears to be steel base with aluminum bleachers on top. See existing pictures which have been forward by Matt Brooks directly to you.
- 5. The maximum bleacher height appears to be about 15.5' stepping down to grade at the field edge.
- 6. Please review the photographs Matt Brooks forwarded by link to Sharepoint. If you need additional information regarding access, contact Carl Lee, CISD Maintenance, 270-403-5563.
- 7. Modification to the bleacher system will include the removal of the first 4-5 seats and adding a platform for ADA access and seating.
- 8. This project consists of adding drainage and laying down a synthetic grass field for football and baseball.
- 9. Geotechnical engineer is to engage a private utility location company.
