- IV. Summary of Comments and Responses
- (1) Subject Matter: Proposed Amendment should remove conflict of interest requirements for school board members participating in the disposal of district surplus property.
- (a) Comment: Kerri Schelling, Executive Director, Kentucky School Boards Association, suggests that the conflict of interest provisions found in Section 4(1) of the proposed amendment should be removed because they are not aligned with the statutory grant of authority, are vague, beyond conflict of interest provisions found in other statutes, and do not address "perceived" conflict of interest.

- (b) Response: The agency carefully reviewed this comment and is deleting the conflict of interest provisions found in Section 4(1).
- (2) Subject Matter: Proposed Amendment should include a process valuation of certain small real property interests.
- (a) Comment: Comment: Kerri Schelling, Executive Director, Kentucky School Boards Association, suggests the amendment include a "minor acquisition review" valuation process for certain small real property interests.
- (b) Response: The agency carefully reviewed this comment and does not believe that it can implement the Kentucky Transportation Cabinet's "minor acquisition review" process. School districts disposing of surplus property must ascertain fair market value and the surest manner for the district to obtain such valuation is through an independent appraisal.
