Re: Proposed 2021-2022 School Calendar Options

As per KRS 158.070 (2)(b)(c)(d) The School District Calendar Committee, after seeking feedback from school district employees, parents, and community members, is presenting a school calendar option to the Board. The calendar option complies with state laws and regulations and considers the economic impact of the school calendar on the community and the state. Prior to adopting a school calendar, the Board shall hear the Committee's recommendation and the recommendation of the Superintendent. At a subsequent meeting, on December 14th, the Board shall approve a calendar for the upcoming school year.

Attached, please find a recommended option for the 2021-2022 School Calendar developed by the District Calendar Committee. This calendar contains 187 days and includes: 170 instructional days, 7 planning days, 4 professional development days, 4 holidays, 1 opening day, 1 closing day, a minimum of 1,062 hours of instruction and 9 potential make up days. If there are any new statutes and regulations released regarding calendar requirements, we will review the information to verify the number of instructional hours on each school's master schedule for the 2021-2022 school year.

Survey feedback results were considered in developing the calendar option.
