Cooperation

The activities and services for the Project shall include, but not limited to:

- a. Marilynn Arnold will provide a link to an unlisted YouTube video entitled "Adult Centered Child Rearing during Covid-19". The video will focus on child rearing from a top down perspective. Additionally, stress and anxiety effects and coping mechanisms for adults and children created by the new "normal" will be briefly touched upon, as well as tips for setting up dedicated remote learning environments for students.
- b. **Boone County School's Resource Centers will utilize the video by distributing via email to Families of their choosing who could use parental support in these changing times. (parenting, anxiety and remote learning resources and assistance). Ockerman Elementary School's Family Resource Center will execute payment in the amount of \$350 for aforementioned service.**
