I'd like to take a moment to express to you my support of moving Trimble Co back HOME among the 31st District. As I shared during our phone call, my top priority as a school principal is establishing a strong school community and culture, be that from an academic or an athletic perspective.

I am from Trimble County, am raising three kids of my own in Trimble County, and am highly involved in community activities. Naturally, when I think about our TC students, I think about their experiences from a young age to the time they graduate from our district. They grow up participating in Youth League activities, alongside athletes from Carroll, Owen, Henry and Gallatin counties. They enter high school, where they attend classes with students from these same communities via participation in iLEAD Academy, the Carroll County ATC, and dual credit courses at JCTC.

Through all of these experiences, they form a true sense of belonging among these peers. Their parents form relationships with parents from these communities. Our local community becomes part of a larger community comprised of these neighboring counties and school districts. We are connected! We grow culture! We grow community - in a much larger sense of the word.

Our current high school alignment is a disconnect from all that I have stated above.
