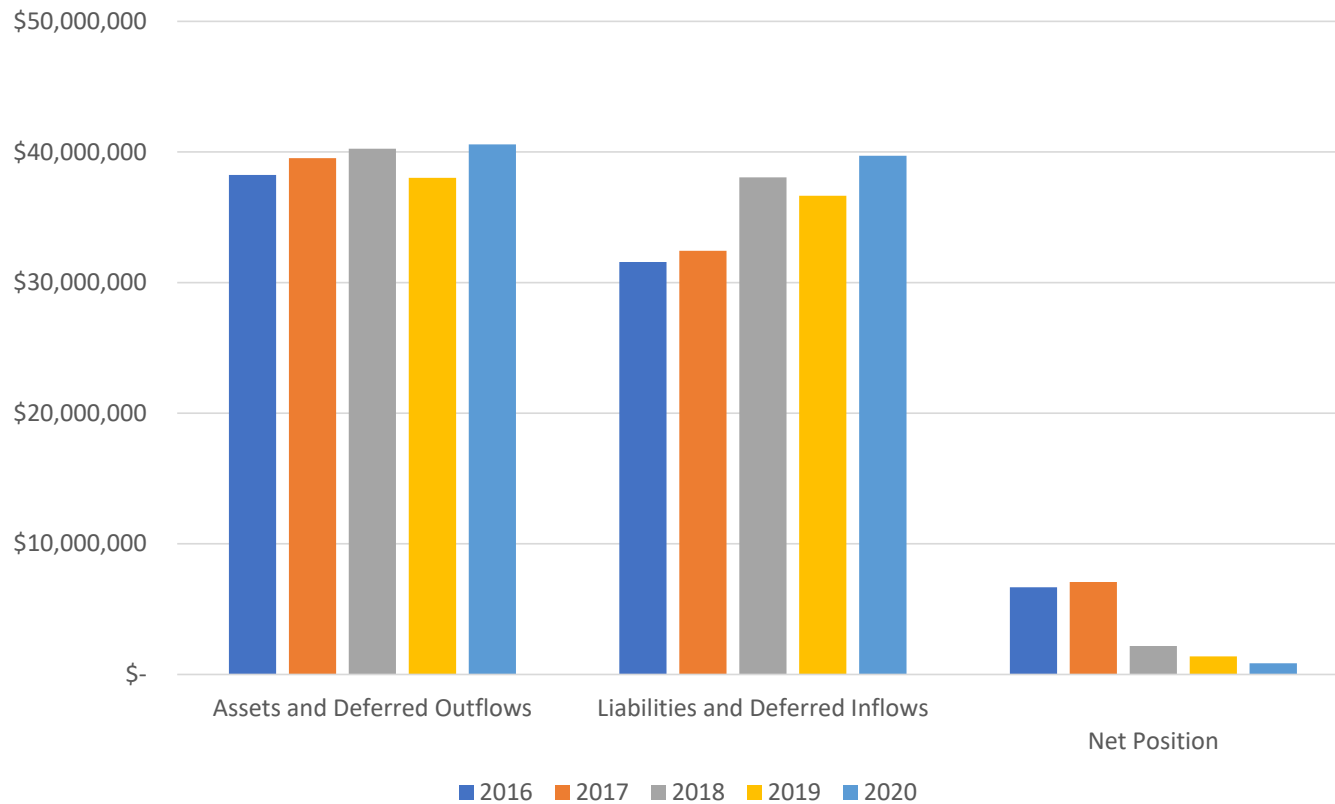

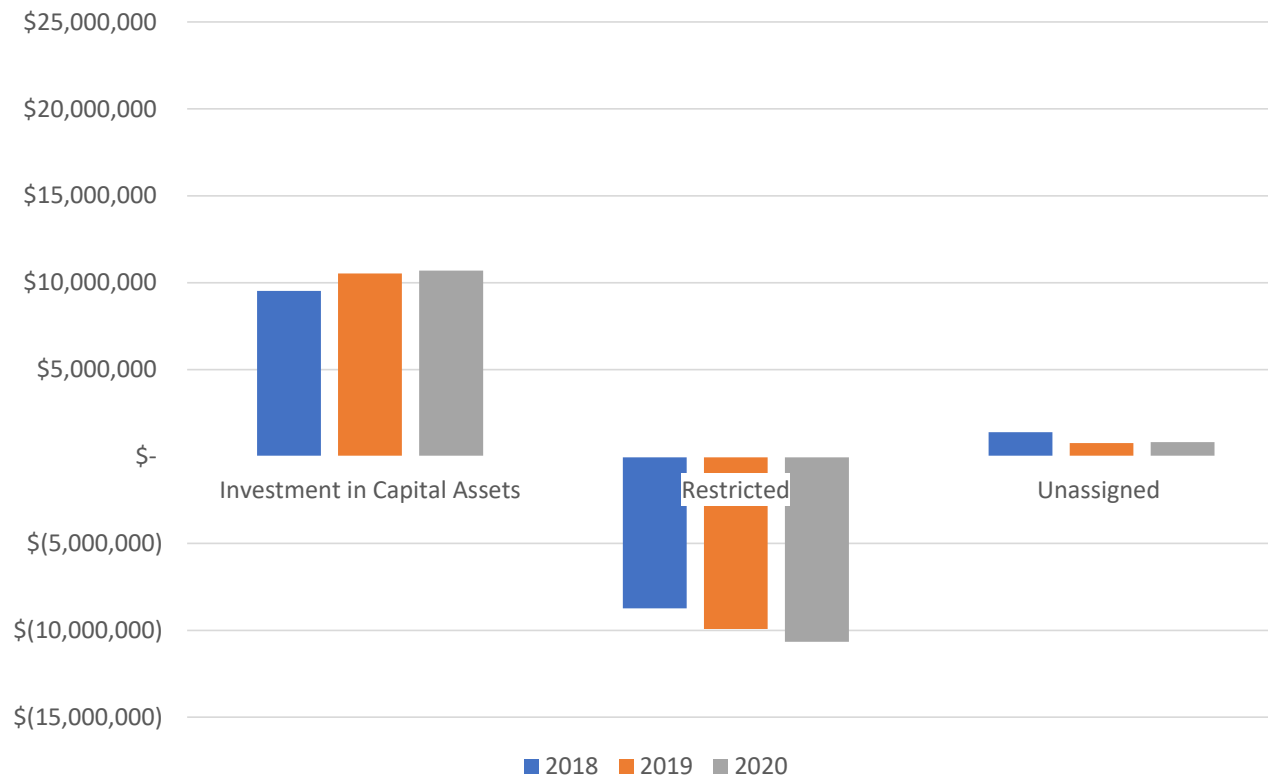

STATEMENT OF NET POSITION

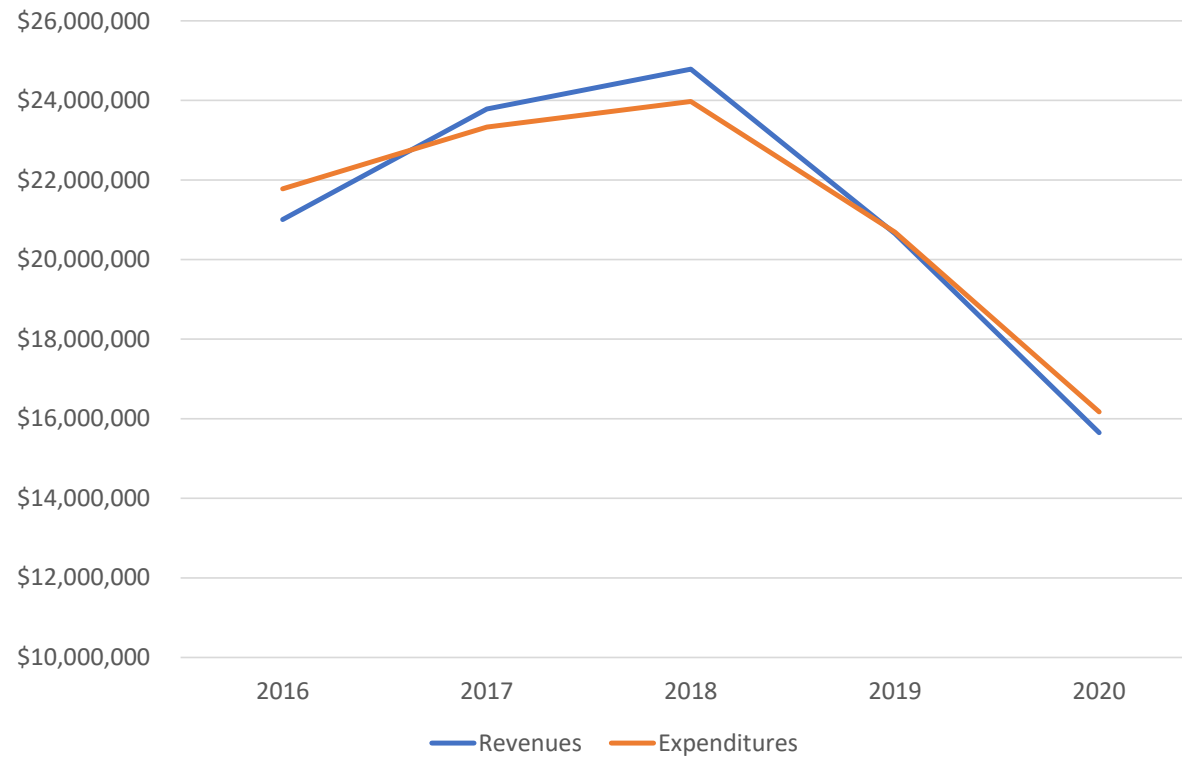
TRENDS DISTRICT WIDE



DISTRICT-WIDE NET POSITION ANALYSIS

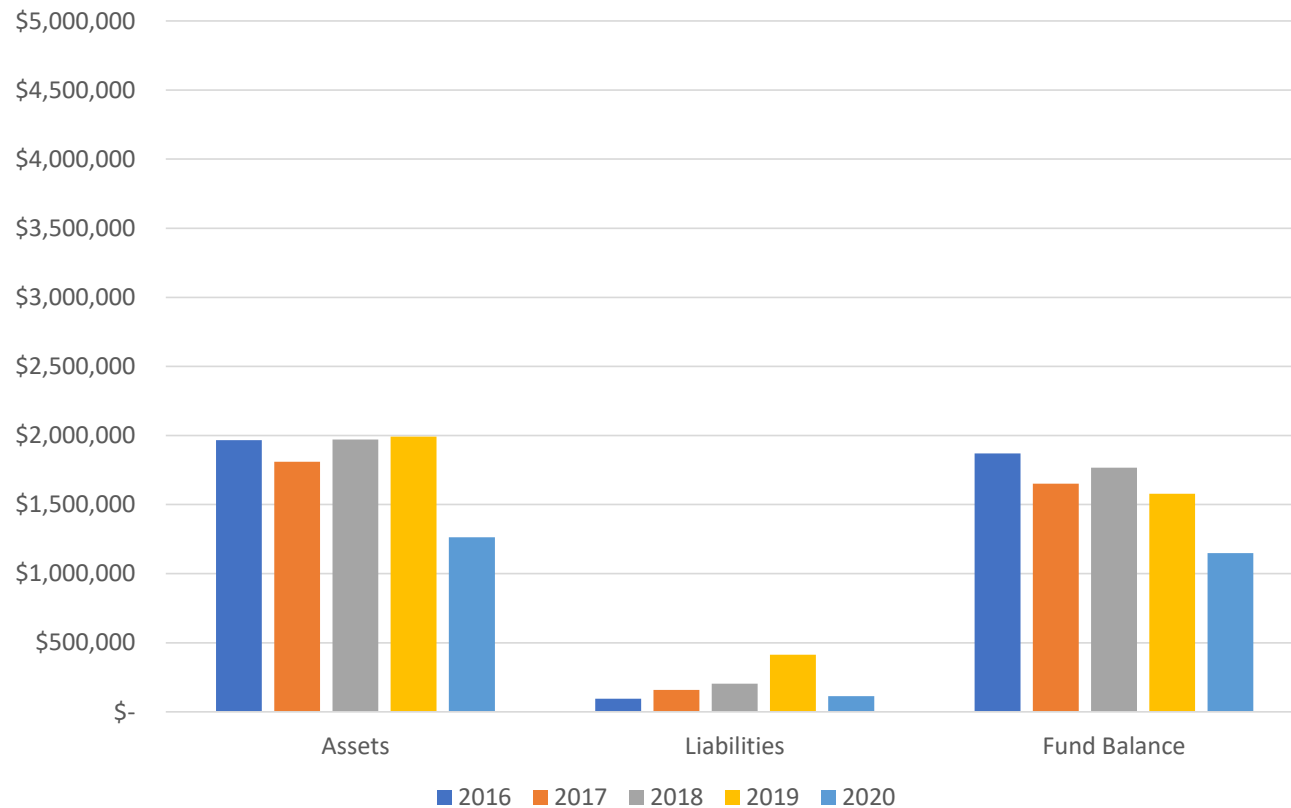


REVENUE OVER EXPENSES – DISTRICT WIDE

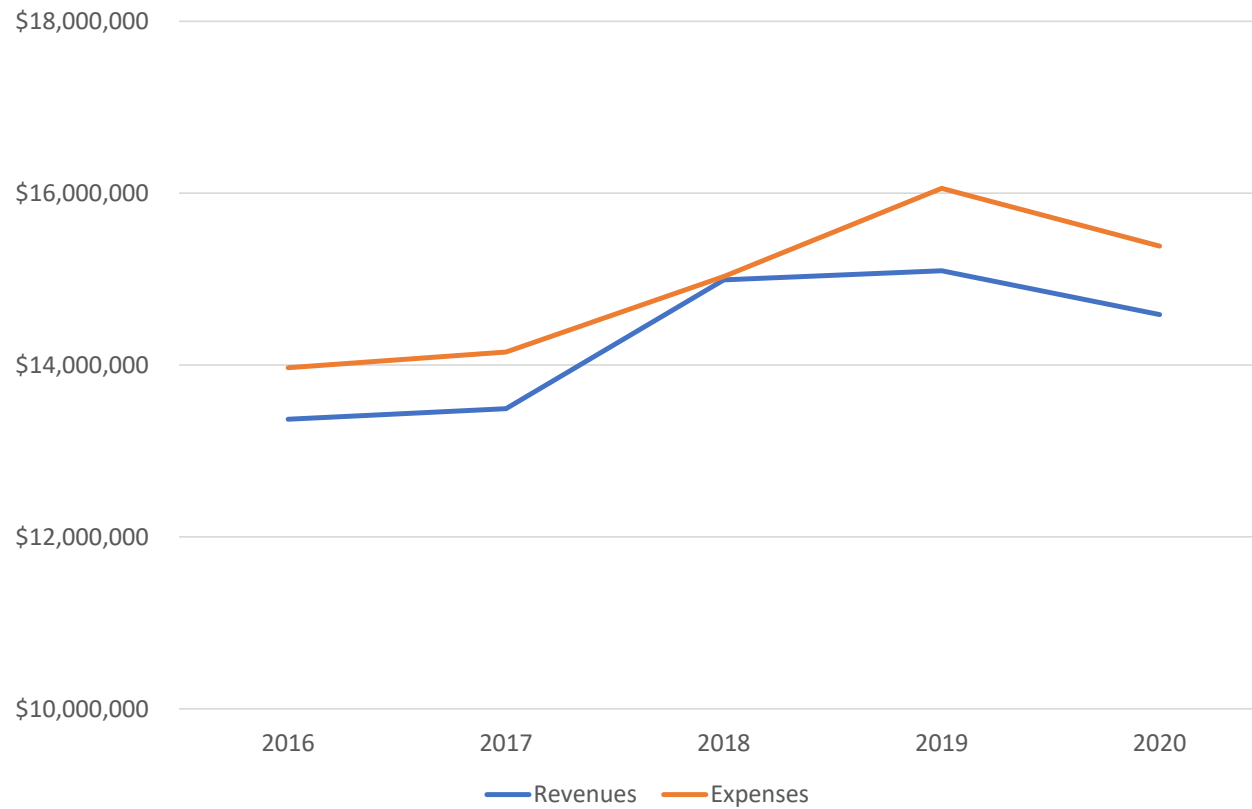

BALANCE SHEET TRENDS – GENERAL FUND

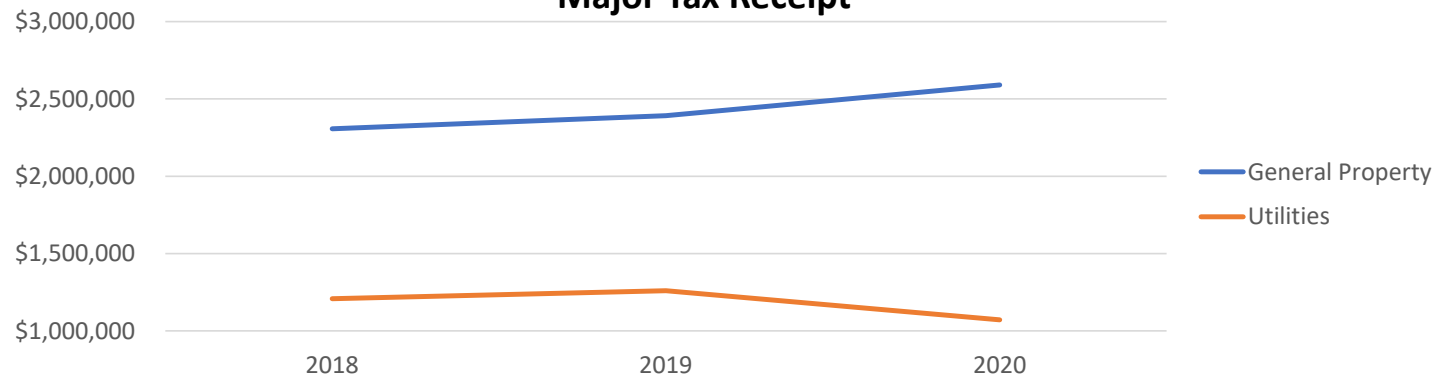


REVENUES OVER EXPENSES – GENERAL FUND

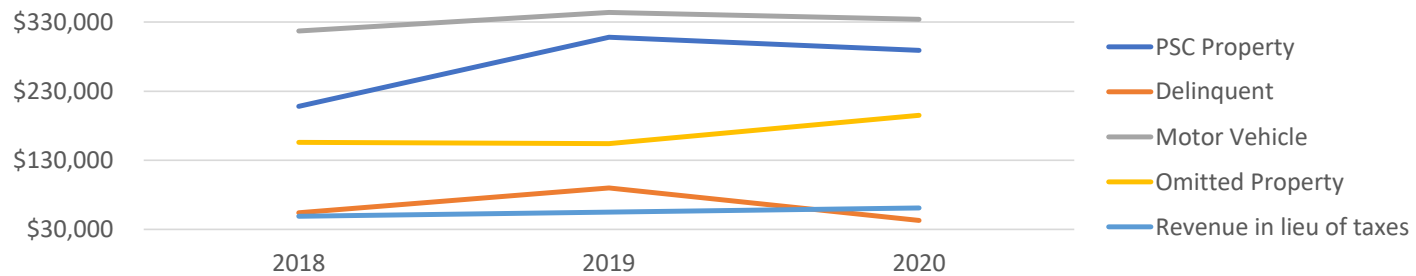


TAX REVENUES GENERAL FUND

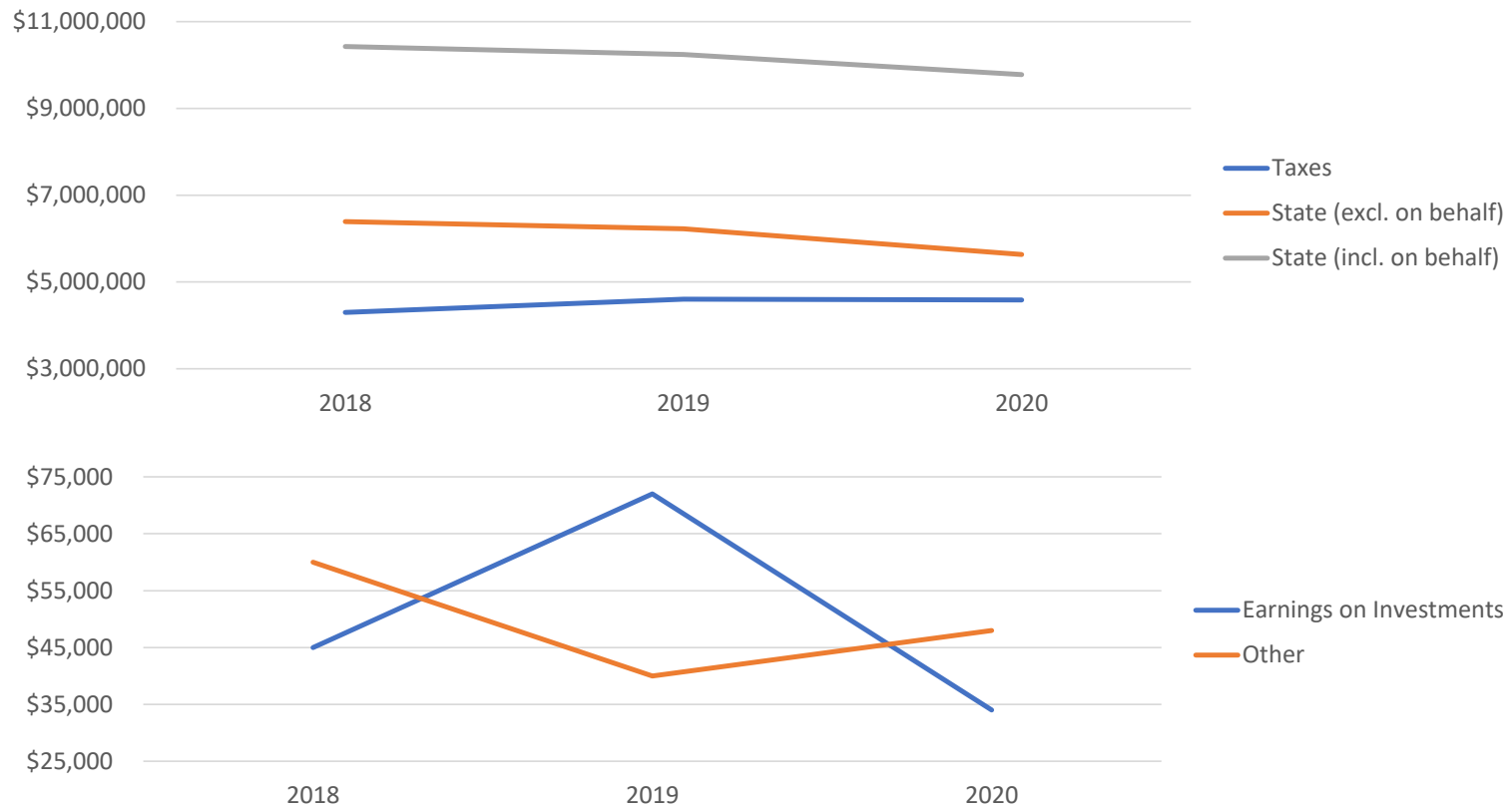
Major Tax Receipt



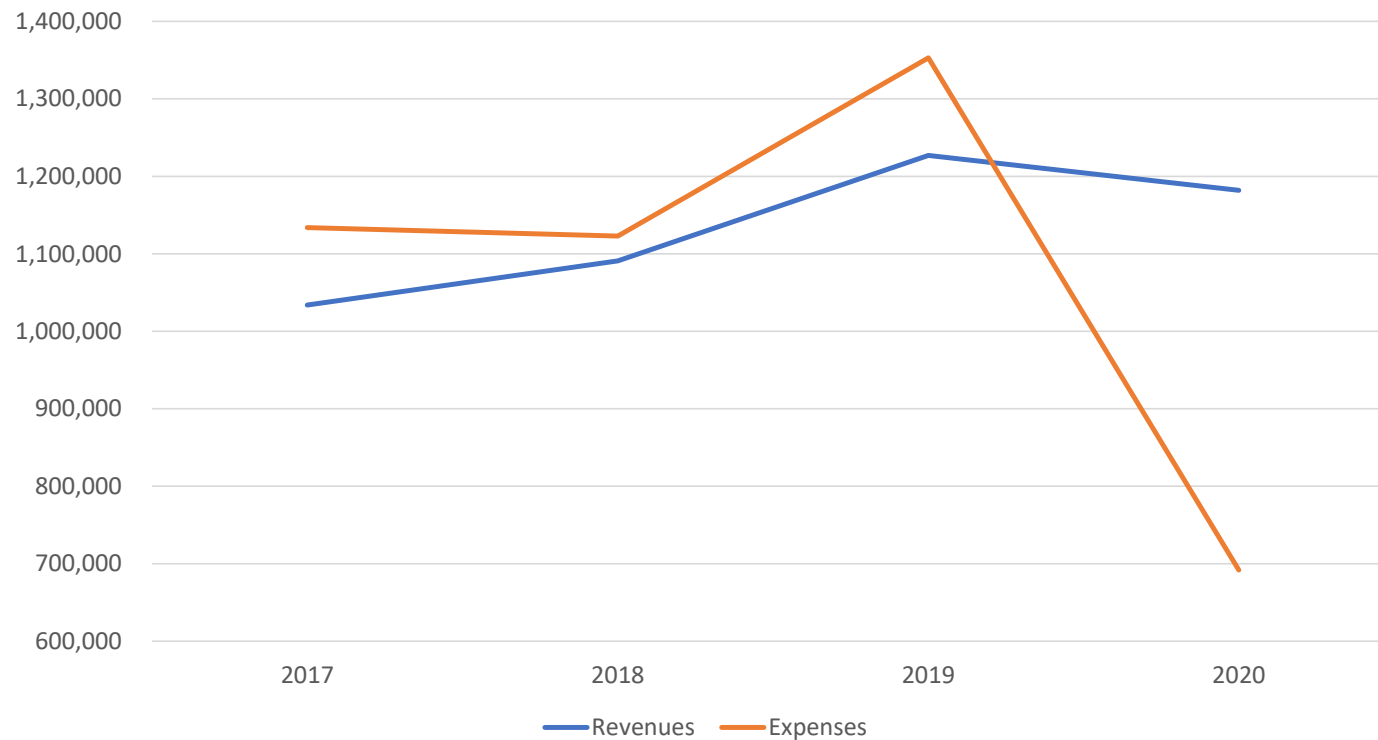
Other Tax Receipts
