Alternatives: None proposed.

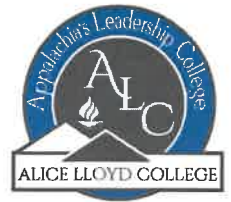

With the object of promoting their co-operation in education, Alice Lloyd College (“ALC”) and Floyd County School District individually also “Party” and collectively the “Parties”, enter into the following Memorandum of Understanding (“MoU”).

2 . Forms of Co-operation

Within such fields as are mutually acceptable for the Parties, the following forms of co-operation, amongst others, may be pursued hereunder:

- Practicum students in K-12 and Special Education classes
- Joint teaching activities
- Joint professional learning activities
- Visits by, and exchange of, scholars, teachers and other staff
- Student teaching
- Students visiting board and SBDM meetings
- Virtual learning and tutoring

3 . Specific Co-operation Projects

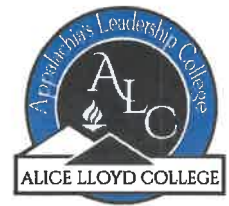
