Special Education Update:

The NKCES DoSE Advisory Board met on Monday, November 16th. The NKCES DoSE meeting was held on Friday, November 20th. We discussed virtual ARC training needs and district special education procedures. On December 18th, the DoSEs met to celebrate two retirements.

Dr. Laura Clarke presented a session at the National CASE Conference held virtually on November 7th. The title of the session was *Leading Data Driven IEP Meetings*.



On November 18th, Dr. Merissa Waddey led KYCEC's New Teacher Academy. Dr. Waddey coordinated the development of online sessions that were created by consultants across the state, including one session created by Dr. Clarke.

Mrs. Becky Nixon attended the December State Directors Meeting with OSEEL on December 8th. The IDEA consultants attended their respective monthly state group meetings. Mrs. Becky Nixon leads the state Low Incidence Task Group.

Dr. Laura Clarke attended a KYCCBD Planning Committee meeting on December 10th. The group is developing monthly sessions for special education teachers to support remote instruction and teacher well-being during the pandemic.

Dr. Laura Clarke presented for Kentucky Special Parent Involvement Network (KY-SPIN) on December 1st regarding literacy strategies to support students with disabilities. Mrs. Kim Snowball presented for KY-SPIN on December 15th regarding math strategies to support students with disabilities.

Dr. Laura Clarke attended Threat Assessment Training Updates from Dr. Dewey Cornell on December 15th.

Dr. Laura Clarke, Dr. Merissa Waddey, and Becky Nixon attended Julie Weatherly's Virtual Special Education Legal Update Training on December 16th. This information was shared with DoSEs.

Mrs. Becky Nixon has worked with John O'Connor, author of *Great Instruction Great Achievement for Students with Disabilities* to provide several virtual training sessions. John O'Connor presented an in-depth review of his "8 big ideas" about virtual teaching and learning to support struggling learners on both November 19 and December 1. Participants increased their understanding of the most effective practices to support learning and social emotional needs for struggling students in a virtual environment. Both sessions were so well received, John O'Connor will be returning to present repeat sessions on January 9 and January 20.

The IDEA consultants added six sessions to the online learning site including Writing Interventions and Assessments for Students with Disabilities as well as training specific to Alternative Assessment.

Mrs. Becky Nixon continues to send our monthly IDEA newsletter to DoSEs. The newsletter is filled with strategies and resources in the area of math, literacy, behavior, transition, assistive technology and compliance. Dr. Laura Clarke and Dr. Merissa Waddey continue to send various information and resources via regional teacher distribution lists that support instruction for students with disabilities. In November and December, these resources focused on remote learning, instructional strategies and teacher self-care tips.

OVR Update

Pre-ETS Workshops: During November and December, Linda Lane continued virtual individual and small group workshops, visiting google classrooms and serving students on alt.assessment and as well as diploma track. Students from Dayton, Lloyd, Simon Kenton, and Boone County high schools participate. Senior year English students at Boone County High School are participating in an Interview Skills mini course that will extend into the new year and finish with mock interviews.



Transition PLN plans, Jan. 12: Guest speaker Misti Carr will share "Transition Mapping", a networking strategy that makes the most of the every day connections to support successful transition for high school students.

Professional Learning (PL) Update:

November Professional Learning: NKCES supported a total of 117 professional learning opportunities focused on academics, culture and climate, and special education during the month of November serving 1166 educators.

December Professional Learning: NKCES supported a total of 137 professional learning opportunities focused on academics, culture and climate, and special education during the month of December serving 1064 educators.

PL Consortium: The PL Consortium met on November 20. Kristen Haddad and Ashleigh DuBois shared information about the Northern Kentucky Institute for Strategic Prevention, a regional grant project to serve all districts in the Grants Consortium. The <u>Virtual Meeting Platforms Accessibility Options</u> document was shared which includes great information regarding all the various platforms used for remote learning. Amelia Brown elicited feedback regarding the Substitute Teacher training NKCES is currently creating.

Title I & Title II Meeting: The Title directors met on November 20 to work collaboratively and support each other as districts maneuver through the implementation of the Title programing.

DAC Consortium: NKCES hosted DAC Consortium on November 17 and December 15. These meetings are epitome of regional collaboration.

Special Education Teachers' PLN: Our Special Education Teachers' PLN Make & Take was held virtually on Dec. 2nd. Our focus was on Visual Supports for Self-Regulation, so we explored calming corners for both in-person and virtual settings, as well as other visual tools. Teachers had the opportunity to customize the virtual tools that were shared with them, and one teacher from RSP emailed information about the incredible "Peace Corner" she'd already created and shared with her students the following day. It's amazing to see how teachers are still seeking their own professional growth and immediately applying what they learn!

November Professional Learning Networks (PLNs): Our PLNs in November included: NKAGE, Physical Education, Culturally Responsive, Instructional Coaches, Arts and Humanities and English Learners. PLNs provide opportunities for educators to grow professionally in a collaborative environment focused on collective learning.

Regional School Programs (RSP) Update:

RSP and TLC hosted the Regional Alternative Program (RAP) meeting on December 9th. Since we are hosting these virtually, they are opened up to the state and we have had great success with discussion and collaboration. The next meeting will be February 24th.

English Learners (EL) Program Update:

The EL Consultants, Heather Ralphes and Daniele Novak, continued to work with students in person and virtually in November and virtually through December. ACCESS testing has been rescheduled by the state to March 1-April 16th. Additionally, Daniele worked with CAL to reschedule the SIOP training, originally scheduled for March, to February 18th, 19th, 24th, and 25th.

NKY Institute for Arts Education (NKIAE):

On November 14, NKIAE hosted virtual professional learning with the Contemporary Arts Center focused on integrating art with science. On November 19, NKIAE teachers participated in virtual professional learning with the Cincinnati Art Museum.

Joe Bertucci hosted the Visual & Performing Arts PLN meeting on November 19, with a focus on mindfulness through the arts.

Mr. Bertucci met with arts integration teams at six schools to assist in planning and implementing lessons (Boone County High School, Ludlow Elementary, Newport Intermediate, Ft. Wright Elementary, Miles Elementary, and Lindeman Elementary). Mr. Bertucci also observed and provided feedback for arts-integrated lessons at Lincoln Elementary, Boone County High School, Arnett Elementary, Southern Elementary, and Williamstown Elementary.

Mr. Bertucci completed the annual performance report for our Professional Development for Arts Educators Grant, and accepted a contract with the Kennedy Center's VSA Program focused on offering professional development in arts and special education.

Grant Consortium Update:

In implementation:

<u>Innovative Approaches to Literacy, Bellevue and Erlanger grants are s</u>till working to address district and school needs, especially in light of COVID. The Grants Consortium will host a joint meeting January 11 to discuss use of funds, data in the new world of COVID, and potential no-cost extension into Year Four. <u>Professional Development for Arts Educators:</u> Professional development continues in many forms for



participating arts and science teachers. Also, mini-grants for up to \$1500 for additional supplies awarded to three schools.

<u>Project Prevent</u>: Report was submitted. Erlanger and Covington are collaborating to plan for Year Two. <u>Strategic Prevention Framework (Regional and EES)</u>:

Regional: Ashleigh DuBois and Kristen Haddad submitted their effective first report prior to the Dec. deadline, less than two months after starting in their work. They also hosted their first steering committee meeting.

EES: Report was submitted before the December deadline. Schools are finding useful information in the CART tool and we expect use to pick up this year once students are back in the buildings. <u>Full Service Community Schools:</u> Erlanger has hired staff for this new grant and is beginning implementation.

New Awards

<u>VSA Kennedy Center Professional Development Program</u>: We were awarded a contract to provide arts integration training for special education teachers.

<u>Drug Free Communities</u> Erlanger-Elsmere will receive \$125,000 per year for the next five years, with potential for an additional five years, to provide substance abuse prevention programming focused largely on early childhood.
