## K-12 Progress Dashboard

#### **Commissioner's Goal:**

Provide transparent reporting of PreK-20 indicators and long-range goals related to student outcomes, the educator workforce (including the diversity of the teacher workforce) and student engagement, benchmarked against other states as measured by the establishment of outcome goals, benchmark identification and the development of a strategic dashboard.

# Proposed Strategic Dashboard Measures

#### **Academic Indicators**

- NAEP grades 4 and 8 reading and math
- ACT language and math (benchmark against 14 states using ACT statewide)
- Postsecondary ready
- AP and dual credit enrollment (equity measure)
- Proficiency gap, grades 3 and 8 (equity measure)
- Graduation rate

#### **Nonacademic Indicators**

- Teacher satisfaction IMPACT Kentucky
- Student engagement
- Student health and safety possible measure using Safe Schools data
- Financial equity possibly look at \$
  allocated to Title I vs. non-Title I
  schools
- Student participation/attendance

#### **Commissioner's Goal:**

Lead a statewide effort to achieve consensus on the future of education as measured by the publication of a future-vision document that defines Kentucky's desired education system and describes the portrait of a Kentucky graduate.
