#### **HISTORY/BACKGROUND**:

Due to the number of students who will be taking the sophomore and junior ACT test in March of 2021 at Dixie, we need to rent additional tables and chairs to accommodate those students along with meeting ACT testing spacing requirements and guidelines. We are seeking retroactive approval for the table and chair rental due to one of our bid contacts having a delay in being able to get the necessary quote information to us. Once they were able to provide the information it was determined that we would not be able to use their services due to a lack of items so we had to seek another vendor which caused the delay.

#### **FISCAL/BUDGETARY IMPACT:**

We have obtained three bids in regards to the table and chair rental with the lowest cost of \$2176.00 for rental from 3/1/21 until 3/10/21. Cost of rental will be paid from Dixie Instructional Funds.
