

Hopkins County YMCA Usage Agreement with Hopkins County Schools

2020-2021

- The YMCA provides pool time Monday-Friday between 3:15pm & 6:15pm. Hopkins County Central High School will practice in the pool from 3:15pm-4:45pm. Madisonville North Hopkins High School will practice from 4:45pm-6:15pm. During this time, participants swim under the direction of their high school coach.
- Madisonville North Hopkins will practice Saturdays 8:30am - no later than 10 am. This pool time is exclusive to high school swim team. The pool opens for YMCA recreational use at 10am.
- The YMCA hosts Swim Lessons on Tuesday/Thursday night. High School swimmers need to be out of the pool by 6:15pm.
- The Dive Team may use the pool on Monday and Friday afternoons after 6pm, and on Saturday from 10:00 a.m. to 11:00 a.m. The pool is not closed during this time.
- The KHSAA start date for high school swimming and diving has been changed due to COVID-19. The season has been extended but not to exceed April 30th, 2021. The YMCA does NOT require a student to be a YMCA member to participate in scheduled high school swimming and diving practices/meets.
- The Hopkins County School System must provide the YMCA with a Certificate of Insurance.
- The high school coaches are Hopkins County Board employees and are not responsible for supervising YMCA members during practice time.
- Coaches must contact the Aquatics Director or Chief Operations Officer to schedule a KHSAA compliant start date and meets.
- Coaches must provide the YMCA Aquatics Director with a roster. The annual usage rate is **\$13,250**. Due to COVID-19 the YMCA will agree to invoice the Hopkins County School System after the season is over in order to avoid any credit/reimbursement due to cancelled practice/meets or quarantined teams.
- Any scheduling changes (school breaks, snow days, etc.) must be discussed with the Aquatics Director/Chief Operations Officer.
- There will be no dry land in the afternoon on YMCA premises. Morning dry land training is permitted for both teams. Student athletes must follow COVID-19 Healthy at Work guidelines while using the YMCA.
- The Aquatics Director/Chief Operations Officer must approve dates and times for scheduling home meets. Schools must not exceed four home meets in one season, per team.
- It is the responsibility of the host school to prepare for a meet. This requires setting up prior to the meet, bringing all necessary copies/materials & cleaning up after the meet.
- It is preferred that a minimum of 1 coach per team hold a current First Aid, CPR and AED certification as well as a lifeguard certification. The YMCA will certify staff at no charge.
- The YMCA reserves the right to deny privileges to any swimmer/coach due to misconduct at the pool.
- Coaches must remain with swimmers after practice until all have been picked up. Only swimmers with a YMCA membership can be left unattended.
- The coaches are responsible for proper care, usage & storage of equipment. The YMCA is not responsible for any lost or damaged equipment.
- The coaches are responsible for putting lane lines in and taking them out.
- It will be the discretion of the head coach to allow a YMCA member the ability to swim in a lane during a practice. The YMCA will block off the schedule as school usage only.
- Swimmers must rinse off in the locker room showers prior to entering the pool.
- Swimmers must dry off after practice prior to entering the building.
- The YMCA aquatic staff is responsible for maintaining the pool water and facility.
- The YMCA aquatic staff has the right to cancel practices/meets due to inclement weather. The School board will make the decision on after school activities.
- Swimmers and coaches agree to abide by all KHSAA/School system COVID-19 safety precautions as well as the YMCA Healthy at Work COVID-19 Guidelines
- YMCA agrees to additional cleaning/safety measures to ensure the higher volume of adults/students are safe.
