<u>Consent Agenda Item (Action Item)</u>: Consider extending the purchase of the MAP Accelerator program for all students in Grades 3-8 at all Floyd County Schools through July 31st of the current school year. This program is a personalized Mathematics online learning tool.

Applicable Statute or Regulation: Board Policy 01.11 General Powers and Duties of the Board

<u>Fiscal/Budgetary Impact</u>: Extending the purchase of the MAP Accelerator program for all students in Grades 3-8 at all Floyd County Schools for the current 2020-21 school year will allow student access throughout the summer and use of the program for any summer programming the district may offer as remedial or extension activities. This program is a personalized Mathematics online learning tool for all Floyd County students in Grades 3-8 and will cost * \$5.00 per student (*Sales Order Attached) to extend its use.

<u>History/Background:</u> MAP Accelerator is a program that ties MAP Growth scores (a program that we currently use as a benchmark assessment) to personalized mathematics learning pathways – complete with high-quality, Kentucky Mathematics Standard-aligned exercises, instructional videos, and practice problems. Teachers can differentiate with ease, and students get support tailored to their needs, whether they're on, above or below grade level. Once students completed the initial MAP assessment this fall, MAP accelerator assigned instructional videos, practice and exercises based on the students resulting MAP scores. This program would help assure we were meeting the individualized needs of our students whether at home or in person.

Recommended Action: Approve extending the purchase of MAP Accelerator online math program for all students in grades 3-8 in all Floyd County Schools through July 31, 2021 of the current school year.
