Consider/Approve contracting with Pearson Education to utilize the Q-Interactive program to administer, score, and report assessments for special education.

APPLICABLE BOARD POLICY:

01.1 Legal Status of the Board

HISTORY/BACKGROUND:

Kenton County currently utilizes a variety of hand-administered assessments for students in the process of evaluation for special education. Our school psychologists and educational diagnosticians manually score many of the assessment protocols in addition to writing reports for each evaluation component. Annually, the KCS D spends approximately \$24,000 on special education evaluations for protocols, testing materials and supplies. The Q-Interactive program, through Pearson Education, would enable the district to improve diagnostic assessment outcomes for students as well as efficiency and accuracy by utilizing a digital format to administer, score, and report evaluations. Q-Interactive is an intuitive, portable system that uses Ipad devices connected by bluetooth to access a digital assessment library. Assessments and resources in the library cover Cognition, Achievement, Behavior, Mental Health, Speech-Language, Motor, and Sensory all of which automatically upgrade to new editions as they are published.
