Dayton High School SBDM Meeting

January 25, 2021

In attendance: Angela Buschle, Jennifer Sparks, Angela Gonzalez, Erin Goetz, Brad Campbell, Scott Meyers

Meeting called to order at 4:00 PM by Mr. Meyers.

Opening Business

- a. Approval of the Agenda
 - a. Motion made by Ms. Goetz to approve the agenda, second by Ms. Buschle . No objections.
- b. Approval of the December Minutes

Ms. Buschle asked a question regarding funds that were discussed in the previous meeting and if the money could be used as part of textbook adoption. Mr. Meyers shared that his understanding is that this would be permissible but he asked for an opportunity to verify. Funds were previously allocated for the senior trip that will not be able to happen due to Covid restrictions. Mr. Campbell noted that he isn't opposed to using that money for textbooks but did note he thought the money should be earmarked for something from seniors because it was coming from money allocated for them. Mr. Meyers mentioned that there is also allocated field trip money that could be used either for textbooks or the seniors. Ms. Goetz noted that there hadn't been a motion on this yet. Ms. Buschle discussed the possibility of adding this discussion to next month's agenda. Ms. Gonzalez asked Mr. Campbell if he had any idea on what he would potentially spend those funds on for seniors. Ms. Goetz mentioned the possibility of using a portion of those funds to purchase yearbooks as a gift for all seniors. Mr. Meyers discussed the potential benefits and issues of doing this. Mr. Campbell asked Ms. Gonzalez if she had any plans or what she might have wanted to see last year as she had a child who was a senior last year. She noted that she would like to see the school be able to do something for the senior students, particularly considering the adapted school year they have gone through.

a. Motion made by Ms. Goetz to approve the November minutes, second by Ms. Buschle. No objections.

c. Good News Report

- a. CASE and CERT testing schedules will be coming out within the next month.
- b. 2nd Quarter Honor Roll and Super Honor Roll lists are out.
- c. A credit recovery program is beginning after school on Tuesday and Thursday for students who have been identified by the school as needing immediate intervention and assistance.

d. Public Comment

a. Ms. Gonzalez asked about the Drug Free Club and whether there are/could be "virtual" benefits for students who are members of the club. Mr. Meyers said he would bring that to the sponsors of the club for consideration.

Student Achievement Report/Data

- a. Mr. Meyers reported grade data from students taking dual credit courses through Gateway. Mr. Meyers also shared honor roll numbers. Mr. Campbell asked about the timeframe of the data for the Gateway dual credit students and if that included the NKU School Based Scholar students it did not.
- b. There will be a graduation tracker meeting next week to ensure that our seniors are on track to earn the credits necessary to graduate. Ms. Stallkamp is developing academic work plans for students who are in danger of not graduating.

Budget Report

a. Discussion regarding which department is up on a textbook rotation. Ms. Goetz brought up if there are "use it or lose it" money that they could devote some money to several departments for textbook adoption. Ms. Buschle noted that someone needs to let Ms. Brown know that there is still a Spanish budget. She also noted that council needs to examine final department order dates for the year. She further noted that department heads need to be alerted/reminded of the date. Mr. Campbell mentioned that the Science department had asked for extra funds at one point; Mr. Meyers said that he has had conversations with the department but not heard anything back. Mr. Campbell said that he would attempt to reach out.

Committee Reports

- a. PLC's Reporting Out Special Education/Library Departments
 - a. Ms. Buschle reported on behalf of the Special Education department. She noted that upper-class students have lower failure rates than during the first semester. She noted that sometimes data can be skewed by a low number of students in a particular class. Ms. Buschle discussed interventions and strategies that are being used with struggling students. She noted that some Special Education services have looked a little bit different than in years past. Ms. Buschle discussed the effectiveness that the Read Aloud program has shown. She also noted that some students have had a great deal of success in "virtual" education and how the department can apply the strengths of that style of learning as we move back towards a more traditional model. Attendance for some groups has been really strong. Ms. Buschle's class continues to collaborate with Sanitation District #1 on a project that benefits the community. The department will be purchasing materials to help students stay organized as well as some adaptive equipment recommended by occupational therapy. Ms. Gonzalez asked a question about students who did not take their mid-term. Ms. Buschle noted that those students had actually been able to make up the mid-term since the report was filed. Mr. Campbell asked if Ms. Buschle had been able to research information on students who were in the former DaytonA program. Ms. Buschle related that the DaytonA students who were moved into regular education

- classes did not have an IEP. Mr. Campbell asked how the work Ms. Buschle is doing with her students is going. Ms. Buschle reported that it is going extremely well!
- b. Mr. Meyers shared the library report on behalf of Ms. Chambers. The "I Love Reading" challenge is currently being sponsored by the library. No further questions were asked of the library report.
