Model Procurement KRS 45A

HISTORY/BACKGROUND:

One van in the facility maintenance department and one van in the technology department must be replaced for everyday use. The main van utilized by the district courier has high mileage. The current maintenance van will be utilized by summer maintenance crews only. The high mileage van in the technology department will be utilized as a spare during service work and repairs to other vehicles

FISCAL/BUDGETARY IMPACT:

The cost for the technology van is \$28,900 and the cost for the maintenance van is \$33,600. The difference is the maintenance van has a higher roof.

RECOMMENDATION:

It is recommended that the Board approve the purchase of a van for technology (\$28,900) and one for district maintenance (\$33,600).
