Division 02: Site Work and Demolition

02.01: 2018.06.04 – Excavation for the new building is on-hold until the demolition of a portion of the existing building is complete.

02.02: 2018.06.04 – Installation of the foundation drains for the exterior site walls is in progress.

02.03: 2018.06.18 – Demolition of a portion of the existing building is complete. The razed materials have been removed from the site.

02.04: 2018.06.18 – Installation of the foundation drains for the exterior site walls and new buildings walls is in progress.

02.05: 2018.06.18 – A temporary gravel exit path from the existing building has been provided from Room No. 114 to the existing sidewalk.

Division 03: Concrete

03.01: 2018.06.04 – Installation of the ramp and site walls continue. The form liners for the textured surfaces and block-outs for the exterior wall light fixtures are being installed.

03.02: 2018.06.04 – Underpinning of the foundation outside of Rooms No. 113 and 114 is in progress.

03.03: 2018.06.18 – Construction of the exterior site walls south of the new exterior stairs have been completed.



03.04: 2018.06.18 – Installation of the foundations and stem walls along the west side of the new addition have been started.

03.05: 2018.06.18 – Installation of under-pinning along the wall of the existing building has started.

Division 04: Masonry

04.01: 2018.06.18 – No items noted.

Division 07: Waterproofing

07.01: 2018.06.18 – Installation of the waterproofing and protection board has been installed on a number of the exterior site walls. In some areas the waterproofing primer and waterproofing has been installed too high. The Contractor was notified of this condition and the Contractor stated it would be cleaned.

Division 08: Doors and Frames

08.01: 2018.06.04 – The door frame has been installed for the temporary exit from Room No. 114. A temporary door has been installed.

Division 16: Electric

16.01: 2018.06.18 – Installation of electrical conduits for exterior items continues.

16.02: 2018.06.18 – Installation of the new electrical panels continues in Room No. 113.

16.03: 2018.06.18 – The new electrical transformer has been set in Room No. 113.

16.04: 2018.06.18 – An electrical conduit with cabling was uncovered on the south side of the building. The MEP engineer looked into the matter and was able to determine it apparently was a feed for a former sewage treatment station. The feeder is shown as 3#8 and 1#6 ground, which looks like what was found. Presumably, this has been long abandoned.

16.05: 2018.06.18 – The demolition contractor severed an existing underground electrical feed that runs around the backside of the existing building. This will need to be repaired.




